The above mentioned action taken report is noted by the ERC.

It is observed / felt that in order to achieve the completion schedule/targets timely, approval of deviation/Extra/Substitute items under each package is utmost necessity of this time.

Performance of DDPR Consultant of AIIMS, Raipur i.e. M/s Hospitech Management Consultants Pvt. Ltd is also discussed during the meeting. It is strictly observed by the ERC that the performance of old DDPR Consultant of AIIMS, Raipur i.e. M/s Hospitech Management Consultants Pvt. Ltd was extremely poor. Wrong calculation of BOQ Quantities/Faulty Designs and



Drawings and Poor Estimation by DDPRC AIIMS, Raipur i.e. M/s Hospitech Management Consultants Pvt. Ltd are the main reason for deviated quantities. It is also observed that due to huge deviation in a quantity the cost of deviation quantities beyond the limit (Above 30% or 100%) is fluctuating due to current market rates, which differs while comparing with original BOQ rates mentioned in tender document of each package.

In the above circumstances, the deviations proposed by the Project Consultant of AIIMS, Raipur i.e. M/s HSCC (India) Ltd is being considered and executed. PMC, AIIMS, Raipur informed that rates are being taken either through quotations or through invoices. These rates are certified/verified by PMC, AIIMS and also checked by Accounts Section within Project Cell, AIIMS, Raipur before taking it to the ERC of AIIMS, Raipur for approval.

By looking to the current scenario, ERC of AIIMS, Raipur has no other options / alternate. Therefore, accordingly corrective actions are being taken (as and when required) to achieve the targets on time in public interest, It is also felt/ observed that without doing this, work/targets will not be achieved/completed.

This item is required as per GFC Drawing of Auditorium Building of AIIMS, Raipur issued by NIT, Raipur. The quantities as per GFC/Site Requirement are more than the quantity catered in BOQ. Hence Deviation is justified. The Job will be executed as per GFC/Approved drawing. This item is proposed as per the GFC Drawings and Site requirement. Execution of this item shall not lead to any undue benefit to the Contractor. This item is verified,



recommended by PC, AIIMS, Raipur. Payment will be made as per actual work done and measurement at site.

Deviation Item No. 2:

 Providing and fixing 18 mm thick gang saw cut mirror polished (premoulded and pre-polished) machine cut for kitchen, platform, vanity counter, window sills, facias and similar locations of required size of approved shade, colour and texture laid over 20 mm thick base cement mortar 1:4 with joint treated with white cement mixed with matching pigment. epoxy touchups, including rubbing curing moulding and polishing to edge to give high glass finish etc. complete at all levels. Extra Item No. 1:

Providing and applying white cement based putty of average • thickness 1 mm of approved brand and manufacture power the plaster wall surface to prepare the surface even and smooth complete

Remarks / Recommendations from PC, AIIMS, Raipur / ERC of AIIMS, Raipur for Extra Item No. 1

As it is in general agreement of all and also pointed out in various meetings and visits that Auditorium Building of AIIMS, Raipur should be of the State of Art. It is intended to represent as a land mark for AIIMS, Raipur.

In view of the same, it is proposed that to enhance the aesthetic value of Auditorium Building of AIIMS, Raipur, White Cement based Putty (DSR Item No. 13.80) may be applied over plastered surface before painting over the external walls. However, this item white cement based putty is not available in BOQ of Package - I and hence shall have to be provided as an extra item.

Quantities as per GFC Drawing /Site Decision. It is certified by PC, AIIMS, Raipur that the proposed extra item is absolutely essential. Execution of this item shall not lead to any undue benefit to the Contractor. This item is verified, recommended by PC, AIIMS, Raipur. Payment will be made as per actual work done and measurement at site.

Extra Item No. 2:

• Providing and fixing flexible pipe for sprinkler - 1200 mm long



<u>Remarks / Recommendations from</u> <u>PC, AIIMS, Raipur / ERC of AIIMS, Raipur for Extra Item No. 1</u>

This item is absolutely essential to execute for the Fire Fighting Works in the Auditorium Building of AIIMS, Raipur. Item is required to be executed as per site requirement for Auditorium Fire Fighting Sprinkler Job. This item is not available in BOQ of Package – I and hence shall have to be provided as an extra item. It is certified by PC, AIIMS, Raipur that the market rate / material and labours as adopted for this statement have been personally verified by M/s HSCC (India) Ltd. as PC, AIIMS, Raipur. It is also certified that this item cannot be got executed through other agency due to interconnected to other agreement items and exigency of work.

Execution of this item shall not lead to any undue benefit to the Contractor. This item is verified, recommended by PC, AIIMS, Raipur. Payment will be made as per actual work done and measurement at site.




