'SPOT COUNSELLING' to be held on 30-08-2017

Spot Counselling for filling up the following Postgraduate Seats of AIIMS Raipur for July 2017 session which remained vacant after Open Counselling, and other seats which might fall vacant by way of surrender/resignation etc. of July 2017 session by 29-8-2017 by 1.00 P.M., will be held on 30-8-2017 at 9.00 A.M. at AIIMS, Raipur. The tentative number of seats available in each speciality is shown below. However the final positions of the seats will be uploaded before start of Open Counselling.

In addition to the above, any seat vacated by the candidate, who had been allotted confirmed seat in 1st/2nd/Open Counselling, by way of surrender, resignation, cancellation etc., by 5:00 PM on 28th August, 2017 (Monday) will be included in the vacant seats available as mentioned in the preceding point for Spot Counselling.

The final list of all the vacant seats including seats vacated as mentioned above will be displayed on AIIMS Raipur website by 5:00 PM on 28th August, 2017 (Monday).

Any seat falling vacant after 05.00 PM on 28th August, 2017 will be advertised in the next session i.e. January, 2018.

1. All those candidates who have qualified in the entrance examination i.e. have secured not less than 50th percentile of marks in the PG entrance examination of the Institute held on 7th May, 2017 will be eligible to participate in this session irrespective of their rank in the entrance examination.
2. The candidates who are interested in attending Spot counselling on the scheduled date are required to remain physically present at AIIMS Raipur along with all original certificates of qualification. Please note that the candidates without original certificates will not be allowed to attend the Spot Counselling.
3. No authorized representative will be allowed to attend the Spot Counselling.

4. The allocation of seats will be made strictly as per rank/merit of candidates in the entrance examination and on the terms and conditions as mentioned in the prospectus.
5. The candidates who have joined P.G. course or have opted P.G. seat elsewhere are required to bring proof of acceptance of their resignation/seat surrender in original in the Spot Counselling otherwise they will not be allowed to attend the Spot Counselling.
6. In case during the Spot Counselling if any ST seats remain vacant (after calling all eligible candidates of ST category) then seat will be transferred to SC category and vice-versa. However, even after interchanging the SC/ST seats, the seats reserved for SC/ST candidates remain vacant, then these seats shall be made available to the candidates of General Category. Similarly, in case the OBC seats remain vacant after calling all eligible OBC candidates then these seats shall be made available to the candidates who belong to General Category.
7. The selected candidates are required to join immediately after they are found medically fit. No extension under any circumstances will be granted.
