- 6. All statuary taxes deduction shall be made as per provisions.



- It shall be the responsibility of the contractor for safety and cleanliness of the Equipment's particularly which are under his sole possession/ use as reqd. Nothing extra shall be paid to the contractor in this regard.

- 9. Any damage done to the existing installation/building particularly due to negligence shall be entire responsibility of contractor to make good the same free of cost.
