7. Unless otherwise provided in the Schedule of quantities, the rates tendered by the contractor shall be all inclusive and shall apply to all heights, lifts, leads and depths of the building and nothing shall be payable to him on this account.
8. The first and final bill payment will be done after completion of work as per specification.
9. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
10. The Contractor shall remove from site all rubbish and debris generated by the Works and keep Work site clean and tidy.
