- 3. Liquidated damages @ 0.5% of quoted value per week will be deducted for delay of work subject to maximum up to 10% of quoted value.

- 5. Time allowed for the **completion of the work** is **15 days**. It will be reckoned from the day award of the work.
- 6. Electrical item will be taken as per mentioned make& specification on schedule of quantity.
- 7. Unless otherwise provided in the Schedule of quantities, the rates tendered by the contractor shall be all inclusive and shall apply to all heights, lifts, leads and depths of the building and nothing shall be payable to him on this
- 8. The first and final bill payment will be done after completion of work as per specification.

- 9. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
- 10. The Contractor shall remove from site all rubbish and debris generated by the Works and keep Work site clean and tidy.
