# Annexure-A

## **Technical Specification for Suction Machine:**

- **1.** Volt- 230 VAC.
- **2.** Rating of motor should be with oil emulsion
- **3.** Suction bottle should be made of polycarbonate material with a capacity-2 x 2000 ml minimum ( with safe valve)
- 4. Gauge-0 to 760 mm Hg
- **5.** Pump -oil lubricate rotary pump.
- 6. Suction tubing- ID 7mm, 5m long and Non collapsible
- 7. Should have air tight lids.
- 8. Should have noise less operation
- 9. Should provide filter to absorb moisture & water particles entering into the rotor.
- **10.** Should have an external provision for topping up lubricant.
- **11.** Should be well designed cabinet made of mild steel powder coated.
- 12. Should bear ISI mark.
