TECHNICAL SPECIFICATION FOR INSTRUMENT AUTOCLAVABLE SEALING AND PACKING UNIT

- 1. The sealing process should be reproducible and can be validated
- 2. Heat up time of less than 100 seconds and sealing time should be less than 5 seconds.
- 3. Should meets standardization requirements in accordance to EN61010-1:2001, EN61326-1:2006.
- 4. Temperature, Contact pressure and sealing time are to be continuously monitored, documented and can be confirmed as part of process validation.
- 5. The easy-to-read LCD display with LED status indicator
- 6. USB interfaces and connection to PC to archive the logs and documentation.
- 7. Should have a power save mode/standby mode when not in use.
- 8. Thermosealers should be equipped with an electronic control of the sealing parameters (time and temperature) & assure a sealing band of at least 10 mm or greater in concurrence with the existing norms.
- 9. Should have automatic adjustment of the temperature, to achieve an effective control of the sealing area heating, thus assuring high quality performance over time.
- 10. Should be able to cut the pouches automatically once the seal is done.
- 11. Technical features
 - a. Power Indian Settings
 - b. External Dimension : (Approx.) 470 x 370 x 200 mm (LxDxH)
 - c. Type of Sealing : with continuous cycle and constant temperature
 - d. Nominal Operating temperature of heating resistance : 180° C

- e. Height of Sealing band : 12 mm

 - b. Steam and gas indicators provide clear colour changes when exposed to sterilization process.

 - i. 200 m x 50 mm
 - ii. 200 m x 75 mm
 - iii. 200 m x 100 mm
 - iv. 200 m x 250 mm
- 14. Certification
 - a. US FDA or European CE may attached
- 15. Warranty
 - a. At least 2 years of Onsite warranty and CMC for at least 5 years after the expiry of the warranty. The rate of CMC will be charged separately which in not mention 7% of basic rate of per year.
