- 3.1 Shockproof moulded ABS Plastic Construction, lightweight & Sturdy, pre-stressed tropicalized construction.
- 3.2 Light Weight Construction with incubator not weighing more than 15 Kgs.
- 3.3 Transparent canopy with mattress.
- 3.4 Two access doors, take-out mattress tray with baby restraining straps.
- 3.5 Optimum Baby Area Size 20 inches x 12 inches.
- 3.6 Warm air circulation system.

- 3.17 Device should be tested as per IEC 60601-2-20 Safety Standard for Transport Baby Incubators.
- 3.18 Should also be provided with transport ventilator for neonate and auto loading trolley.
