### Terms & Condition

- 1. Rate should be mentioned in word and figures both.
- 2. GST (Kindly mention in above table) should be clearly mentioned in the offer.
- 3. Delivery Schedule within 15 days from the date of issue of PO.
- 4. Price should be F.O.R. Destination basis (Transfusion Medicine & Blood Bank).
- 5. LD @ 0.5% of delayed supply per week or part of week for delay of supply of material subject to maximum up to 10% of delayed supply should be deducted.
- 6. Quotation No/Name and Due date of opening must be written on top of the envelop.
- 7. 100% payment against received and acceptance and satisfactory installation of material.
- 8. Brand and make should be clearly mentioned in offer.
- 9. AIIMS Raipur reserves the right to place the order for full or part quantity to one or more items.

- 10. RTGS detail required for payment purpose.
- 11. Validity of offer should not be less than 90 days.
- 12. Supply, Installation and commissioning will be done by firm (if applicable).
- 13. Firm to submit documentary evidence in support of claim for GST at the time of submission of Bills.
- 14. The quantity shown in above column are totally tentative, it can be increase and decrease at the time of placement of order.
- 15. The bidder must quote for 1 year onsite warranty for Portable Autoclave as per the above mentioned Specification from the date of completion of the satisfactory installation as certified by the department.
- 16. The bidder should submit their quote for subsequent 1 year onsite AMC for Portable Autoclave, as per annexure-B but it should not be more than 4% of the quoted unit price.
- 17. Failure to comply this condition will entail the rejection of the quotation/bids. The Price comparison shall be made taking into account on basis price and post warranty AMC. The Rate Contracting Authority reserve the right to award AMC shall be quoted for equipment. So the price of AMC should be quoted according to the cost of equipment.
- 18. The amount of AMC would be released to the supplier on successful completion of the maintenance of that particular year duly certified by the department.
- 19. Quoting price for Portable Autoclave and AMC is mandatory. Lowest one will be deciding i.e. L1 = Item price with 01 year warranty + 01 year AMC
- 20. The 10% of total contract value may be with held as security deposit during the warranty period of assets (if applicable).

#### Portable Autoclave

- 1. Portable microprocessor-controlled fully automatic, rapid autoclave suitable for sterilization of unwrapped instrument, wrapped instruments, packs and special cycle for liquids.
- 2. Capacity of minimum of 100 litres.
- 3. Have 2 more programmable cycles to allow custom creation of different cycle parameters for special sterilization needs. The programmable cycle should allow change of Time. Temperature, Dry time and Vent.
- 4. Should have three or more Air removal purges, prior to sterilization.
- 5. Pre-programmed cycles should have selection of at least 5 programs.
- 6. Have a microprocessor-based fault detection circuit for monitoring all functions of sterilizer during a cycle, giving necessary signals to alert operator.
- 7. Should meet the requirements of ASME boiler and Pressure Vessel Code; Pressure Equipment Directive (PED) & EN 13445 norms of equivalent.
- 8. Should be BIS and CPCB standards of US FDA or European CE-class II A certified.
- 9. Electrical safety standards such as IEC class 1 or ISO standards.
- 10.Printer should be provided for recording cycle, cycle time, temperatures and pressure.
- 11.Should have Front filling and Drain facility behind front door, for safety. Should incorporate all safety features including fault detection circuit, continuous monitoring of chamber temperature to prevent overheat condition; audible alarms upon detection of a Fault with program.
- 12.Display should indicate cycle selected, cycle temp and exposure time for selected cycle.
- 13.During cycle, display should reflect messages indication status of cycle and errors.
- 14.During sterilization mode, LCD display should show—remaining cycle time, temperature and pressure.
