Technical Specification for Semi Automated Urine Strip Analyzer:

- 1. The unit should work of reflectance photometer to evaluate the color intensity of each test zone
- 2. The unit should have three wavelengths viz 470nm, 525nm and 625nm.
- 3. The unit should have incubation period of 60 seconds.
- 4. The unit should have throughput of around 600 samples/hr.
- 5. The unit should have strip position check system.
- 6. The unit should have concealed waste container for used strips disposal.
- 7. The unit should give results in SI. conventional and arbitrary units.
- 8. Company should provide 10 sets of two level ready to use liquid stable urine controls free of cost along with the instrument.
- 9. Company should provide tri-level control strip for instrument QC free of cost along with the machine.
- 10. Instrument should be touch screen with color LCD display.
- 11. The unit should have built in printing capability .
- 12. Instrument should have option to connect to bar code reader via USB port.

- 13. Unit should have memory capacity for 2000 measurements with all details like data by date and sample ID.
- 14. Unit should have external ports RS 232 and also 2 USB ports for LIS connection.
- 15. Power supply : 220-240 V; 50-60 HZ.
- 16. Should have European CE- USFDA certification or BIS approved.
- 17. The calibration, IQ, OQ and PQ of the instrument should be performed at the time of installation and certificates should be provided
- 18. UPS backup adequate for the duration of one cycle of processing or half an hour UPS backup should be provided.
- 19. Start up kit for at least 5000 test strips of 10 parameters should be provided free of cost along with the machine.
- 20. Document supporting track record and satisfactory performance form institutes of national importance (minimum one) should be provided.
- 21. Support for induction and follow up training of technical staff, on site standardization and troubleshooting of procedures/ test to be provided by the company.
- 22. Three (03) years warranty should be provided.
