6. The system should be operable in electric power supply range of 200V to 240 V.
7. The system should have battery backup of at least 12-16 Hrs.
8. The system should have Bluetooth enabled app for data collection of patient for wound analysis and system management.
9. The system should have CE certification.
10. The systems should have replaceable filter system for enhanced patient patient safety and prevent corss infection.
11. All the under mentioned consumables/Dressing should be supplied with each system.
12. Warranty/Garantee three (03) Year.
13. CMC (With spares) for 02 years after expiry of Warranty.
14. Hands on training to the manpower designated by institution- free of cost.
15. Minimum four Govt. Institute (Hospital) order copy of dressing and system.
