1. It should have pre-programmed mixing parameters should be able to mix various materials mixes investment, plaster, die material and duplicating silicone
2. It should have self-explanatory user interface and have feature of display, which shows all program parameters i.e., initial spatulation / mixing / post-evacuation: rotational speed, rotational direction and time, included the individual program and requested product name
3. It must be capable of being wall mounted

4. Unit must have high torque of the mixing motor to ensure reliable processing of large amounts of mixing material
5. Fixed table for placement of mixing bowls
6. Automatic bowl connection for Convenient one-hand operation,
7. The unit should be supplied with the following mixing bowls to mix materials
 - i. 200ml mixing bowl with paddle – 1pc
