### **Specification**

1. Specially designed for rapid non operative pleural and chest drainage.
2. Super smooth kink resistance tubing ensures uniform flowrate.
3. Catheter with Trocar : Atraumatic, soft rounded, open distal end with two lateral eyes for non-traumatic insertion.
4. Marking provided at 5,10,15 & 20 cm from the distal tip to help ascertain depth of penetration.
5. Flat handle facilities easy maneuverability.
6. Cross side eyes to prevent tissue aspiration.
7. Large smooth drainage eyes for efficient drainage.
8. Proximal end is fitted with tapered connector for easy connection to drainage bottle.
9. Sterile, individually double packed in peelable pouch.
