Specifications for body bags:

- 1. Purpose to hold and transfer adult dead bodies.
- 2. Size Flat dimension (unopened bag) 84" X 36".
- 3. Capacity to hold dead body upto 200 kg.
- 4. Material Non porous, laminated, leak-proof, sturdy, crack-resistant (upto 60° C) material to hold dead body of maximum 200 kg weight.
- 5. Construction Handles 9" long (free ends) on either side of the bag (2" wide belt of sturdy material like nylon) with reinforcements fused into the bags across the entire width of the back surface 20" from the head end and foot end and one handle at the head in the middle.
- 6. Identification tag 5" X 3" transparent pocket for holding identification tag of the dead person.
- 7. All the seams to be heat sealed (not stitched) to ensure no leakage.
- 8. Transparent Window at head end of the bag 25" X 15" for visualization of the face of the person.
- 9. C shaped zipper arrangement 2" from the margins on three sides of the bag for ease of packing the body into the bag.
