## **Terms & Conditions.**

- 1. The cost of Comprehensive Annual Maintenance Contract (CMC) which includes preventive maintenance, labour and spares, after satisfactory completion of Warranty period may be quoted for next 5 years as contained in the above referred contract on yearly basis for complete equipment.
- 2. There will be 98% uptime warranty during CMC period on 24 (hrs) X 7 (days) X 365 (days) basis, with penalty, to extend CMC period by double the downtime period.
- 3. During CMC period, the supplier shall visit at each consignee's site for preventive maintenance including testing and calibration as per the manufacturer's service/ technical/ operational manual. The supplier shall visit each consignee site as recommended in the manufacturer's manual, but at least once in 6 months commencing from the date of the successful completion of warranty period for preventive maintenance of the goods.
- 4. All software updates should be provided free of cost during CMC.
- 5. If there is any lapse in the performance of the CMC as per contract, the proceeds Annual CMC bank guarantee for an amount of **Rupees i.e.** (equivalent to 2.5 % of the cost of the equipment as per contract) shall be payable to the Consignee.
- 6. **Payment terms:** The payment of Annual CMC will be made against the bills raised to the consignee by the supplier on yearly basis @ 50% of annual CMC charges after

- satisfactory completion of said period, duly certified by the HOD concerned. The payment will be made in Indian Rupees.
- 7. **Paying authority:** DDO, AIIMS-Raipur, G.E. Road, Tatibandh, Raipur-492001, Chhattisgarh.
