Specification for IM Injection Trainer Manikin

- 1) Manikins should be combination of epidermis, dermis, fat and muscle.
- 2) Epidermis should be replaceable.
- 3) Material should be latex free.
- 4) Material should release subcuticular liquid quickly on peeling of epidermis layer.
- 5) Tissues should be soft and warm for realistic touch.
- 6) Strap should be provided with manikin for hybrid simulation.
- 7) Manikin should allow subcutaneous injection.
- 8) Intradermal and intramuscular injection should be trained.
- 9) It should allow training of tissue management.
- 10) Professional-to-patient communication should be trained.
- 11) It should come with skin pad and muscle block for injection trainer- 1 No., epidermis for Injection-2Nos.

Specifications for Adult Training arm for Peripheral Intravenous Therapy:

- 1) Training arm must have design of life-like adult arm.
- 2) Arm reproductions must have replaceable skin and multi vein system to ensure longevity of training arm.
- 3) Venipuncture must be practiced in antecubital fossa or dorsum of the hand.
- 4) Peripheral IV lines insertion and removal must be performed.
- 5) Accessible veins should include median, basilic and cephalic.
- 6) Palpable veins should have ability to enable site selection and preparation.
- 7) Infusible vein must allow peripheral therapy with IV bolus or push injection method.
- 8) Training arm should have capability to articulate with same category adult manikin.
- 9) 1 arm reproduction, 1 replacement skin and multi vein system, 1 bottle of red simulated blood, 1 can of manikin lubricant, 1 blood bag with tubing and connector, 1 clamp and hook, 1 set shoulder attachment hardware, 1 carry case and direction for use must be supplied as a standard supply with training arm.
- 10) It should be ISO certified.

Terms and Condition
