- 1. Supplier must provide technical support in person on site with 48 hrs. of lodging the complaint.
- 2. Quotations are called from original manufacturer or their authorized distributor who are in position to provide technical support as mentioned on point no 1.
- 3. Supplier will have to set up the antibody on site at AIIMS Raipur within 7 days after the delivery of consignment.
- 4. In case of unsatisfactory results/rejected items, supplier must collect the items within 7 days.
- 5. In case of unsatisfactory results of the antibody the supplier must replace the antibody within 15 days & only one chance will be given to replace the antibody.
- 6. Penalty for delay in delivery of any/all the item within in prescribed time be imposed on total value of purchase order.
- 7. Antibodies should have a shelf life of 2 years at the time of supply.
- 8. There should not be any capping for overall price.
- 9. It will be binding to vendor to supply the antibodies which they have committed to supply. Failure to supply due to any reason, will lead forfeit of PBG.
- 10. For concentrated antibodies, vendor will have to demonstrate the results on site at the required dilution. If the results are not satisfactory then antibodies will be rejected.
- 11. The antibodies should be compatible with any secondary antibodies used in the department.

Terms & Conditions

- 1. Rate should be mentioned in words & figures both.
- 2. **GST rates applicable** on your quoted item may please be confirmed.
- 3. Delivery Schedule- within 15 days from the date of issue of P.O.
- 4. No additional documents related to this NIQ will be entertained after NIQ opened.
- 5. Price should be F.O.R. for Destination basis (i.e. Concerned Department).
- 6. LD@0.5% of delayed supply per week or part week for delay of supply of material subject to maximum upto 10% of delayed supply should be deducted.
- 7. Quotation No/Name and Due date of opening must be written on top of the envelop.
- 8. The bidder participating in the LPC may have local registered office in Chhattisgarh.
- 9. The GST registration details may please be furnished.
- 10. Please confirm if there any change (Upward/Reduction) in your Basic Price structure. And you are also requested to pass the Input Credit as per the following Anti Profiteering Clause of GST.
