#### **KRAS Mutations Detection Kit Specifications**

- 1. The kit should be a real-time Polymerase Chain Reaction (PCR) assay kit for the detection of KRAS mutation in the genomic DNA extracted from fresh, frozen or formalin-fixed paraffin-embedded (FFPF) tissue using FFPE DNA extraction kit.
- 2. Kit should be compatible with Real Time PCR instruments like Himedia Insta Q96 Model-LA1073.
- 3. Application support related to the kit like setting up assay, running tests, standardizing the protocol and analysis and interpretation of the result to be provided by the manufacturer company/brand.
- 4. Kit should have a min. expiry of 1year.
- 5. Should have a clinical performance study conducted demonstrating the clinical validity of the KRAS PCR Kit as a CDx test to aid the identification of NSCLC patients for treatment with Sotorasib & adagrasib.
- 6. Kit needs to be clinically validated on non-small cell lung cancer (NSCLC) and colorectal cancer (CRC) tumor samples.
- 7. The kit should be based on ARMS PCR technology
- 8. Kit must comply with EU IVD Directive 98/79/EC
- 9. This should be sensitive, robust test that can detect low levels of mutant DNA from the sample taken.
- 10. The kit should be Ready-to-use system with simple workflow.
- 11. The kit should detect KRAS mutations by for 12ALA, 12ASP, 12ARG, 12CYS, 12SER, 12VAL, 13 ASP
- 12. The kit should have Ready-to-use solutions including all reagents for RT and qPCR.
- 13. The kit should have Precision: 99.6

#### Additional terms & conditions
