(QUOTATION NOTICE)

Notice for disposal of condemned e-waste scrap items on "As Is Where Is Basis"

Sealed quotations are invited from intending registered-waste Recycler/Dismantlers with Central Pollution Control Board, MoEF, GOI or with State Pollution Control Board under E-waste (Management Rules), 2016 for disposal of condemned e-waste items (List is tabulated at **Annexure 1**). The quotation should be submitted to New Admin Building, Central store, 6th floor C- Block, Gate No. 05, AIIMS, Raipur office of the Stores Officer up to **30/04/2026** before **15:00 hrs**. The quotations will be opened on the same day at **15:30 hrs**. in presence of bidders or their authorised representatives, if they want to be present.

A total of 01 Lot shall be sold to the bidder who will quote the consolidated highest rate. Interested bidders, if so desire, may contact New Admin Building, Central store, 6th floor C- Block, Gate No. 05, AIIMS, Raipur office at Contact No. 7032485083/9828893302. The bidder may inspect the said condemned items from **03/04/2026 to 11/04/2026** between 11:00 a.m. and 3:00 p.m. on any working day.

Two separate sealed envelopes should be used for submitting 'Earnest Money Deposit evidence' and 'Financial Bid' in the format mentioned at **Annexure 2** respectively, subscribing on the envelopes (a) Earnest Money evidence for disposal of Condemned e-waste Scrap and (b) Financial bid for sale of condemned e-waste scrap as per **Annexure '2'**. The terms & conditions of this notice are as follows:-

Terms and Condition

1. Bidder must be registered as a Recycler/Dismantler of e-Waste with Central Pollution Control Board, Ministry of Environment and Forests, Government of India or with the State Pollution Control Board under E-Waste (Management Rules), 2016. Bids received from the firms other than so registered will be summarily rejected.
2. Bidder should be registered with GST Department.
3. Bidders have to furnish bid security (EMD) along with their bids. The amount of bid security shall be **Rs. 4,100**. The EMD shall be forfeited if the bidder unilaterally withdraws, amends, impairs or derogates from his offer in any respect within the period of validity of his offer or fails to deposit the security deposit within seven days from the date acceptance of the bid. The EMD may be deposited through e-pay gateway of AIIMS Raipur Website (preferred mode) or through Demand Draft. The evidence of such deposit should be enclosed in separate Envelope.
4. Successful bidder, herein after referred to as purchaser, shall have to pay **100% of the total value of the contract (Including GST) as Sales Value (SV) within 15 calendar days, to be enumerated from the date of intimation to the H1 bidder through e-mail**. The sale value shall be deposited through e-pay gateway available at AIIMS Raipur website.
5. Other bidders other than H1, the EMD shall be released within 30 days from the date of declaration of result. No interest shall be payable on such refunds. The EMD deposited by the successful bidder shall remain with the seller till payment of the Sales value (SV) money has been made. The EMD may be adjusted as part of the total SV money.
6. Any extension of time for the payment of Sale Value (SV) with **late payment charges @ one per cent per week or part thereof of total sale value up to two weeks only** and, thereafter, the EMD will stand

forfeited without notice. No interest will be paid to the purchaser for the amounts paid or deposited and subsequently found refundable to the purchaser under any of the conditions of the contract;

7. Delivery order shall be required to be produced to take delivery of the material from the custodian. The Delivery Order (DO) shall be issued after submission of receipt of payment of total Sales Value only.
8. The purchaser will take delivery of material **within seven days** from the date of issue of Delivery Order (DO), else the earnest money deposit will be forfeited and offer of the sale of store stand cancelled.
9. The weightment or counting and loading will be done in the presence of the purchaser or his authorised representative. The arrangement for loading and transportation will be made by the purchaser.
10. No weightment or counting will be permitted for resale among the purchasers themselves.
11. Mere payment of the Sale Value (SV) will not tantamount to completion of purchase and the material will become property of the purchaser only after the sale has been completed and the stores have been physically removed from the Estt premises.
12. If due to any compelling circumstances, it is not possible on the part of the Estt to complete delivery after payment has been received, a refund of the value of undelivered goods will be made to the purchaser, who will have no claim for further compensation.
13. The ground rent **charges @ one per cent per week or part thereof of Sale Value (SV)**, may be charged for delayed lifting due to default of the contractor when such delay is not acceptable to the Estt and reasonable time period has been given to the contractor through appropriate notice.
14. The delivery will be made on "**as is where is**" basis. No picking or choosing or sorting will be allowed in the Estt premises.
15. The purchaser shall make his own arrangements for lifting the materials from the site immediately after the delivery order has been given to him. The Estt will not be responsible for loss, destruction, damage or deterioration to the material due to any cause whatsoever thereafter.
16. The Director of the Estt reserves the right of withdrawing from sale any material at any stage without assigning any reason thereof.
17. The bidder quoting the highest price will be accepted. If the price offered by that H1 bidder is not acceptable, negotiation may be held only with that bidder. In case such negotiation does not provide the desired result, the reasonable or acceptable price may be counter offered to the next highest responsive bidder(s).
18. No documents related to this Notice will be entertained after opening of Notice.

19. Legal Jurisdiction:

The sales agreement shall be deemed to have been concluded in Raipur, Chhattisgarh and all obligations hereunder shall be deemed to be located at Raipur, Chhattisgarh and Court within Raipur, Chhattisgarh will have Jurisdiction to the exclusion of other courts.
