## RECRUITMENT TO THE POST OF LOWER DIVISION CLERK (LDC) IN AIIMS RAIPUR ON REGULAR BASIS – WAITING LIST

Notice for recruitment to various Gr. 'B' and 'C' posts in AIIMS Raipur on regular basis was issued vide Admin/Rec./Regular/ Group'B & 'C/2016/AIIMS.RPR/ dated 10.03.2016.

2. Computer Based Test (CBT) for recruitment to the post of LDC along with other posts was conducted on 18.02.2017 and 19.02.2017. List of shortlisted candidates for document verification & Skill Test on the basis of marks scored in CBT was declared vide Notice No. Admin/Rec./Regular /Group 'B' & 'C' 2016/AIIMS.RPR/ dated 24.5.2017 and Notice No. Admin/Rec./Regular/Group 'B' & 'C' 2016/AIIMS.RPR/ dated 24.5.2017 and Notice No. Admin/Rec./Regular/Group 'B' & 'C' 2016/AIIMS.RPR dated 16.07.2017. Typewriting Skill Test for the post of **LDC** was held in AIIMS Raipur on 24th Dec. 2017 and result of the Skill Test was declared on 6.2.2018. Final result was declared vide Notice No. 5/1/2017-Rec.AIIMS Rpr dated 21.2.2018. Out of the 30 candidates recommended for appointment, 05 candidates (UR-04 & OBC-01) have failed to join the post inspite of sufficient opportunity given to them and hence their candidature has been cancelled.
