RECRUITMENT TO THE POST OF LIBRARY ATTENDANT GR.II IN AIIMS RAIPUR ON REGULAR BASIS

FINAL RESULT

Recruitment notice for filling up the post of **Library Attendant Grade- II** [UR-03] on direct recruitment basis in AIIMS Raipur was issued along with other posts vide Admin/Rec./Regular/Group 'C'/10/2017/AIIMS-RPR/2156 dated **06.12.2017**. Computer Based Test (CBT) for recruitment to the above posts was held on **27th-28th Feb. 2018**. The result of the CBT was declared vide notice dated 31.8.2018 and document verification of the shortlisted candidates was held on 30.8.2018 and 01.09.2018 at AIIMS Raipur. The eligibility status of the candidates after verification of their documents was uploaded on the website of AIIMS Raipur vide notice dated 05.10.2018 and objections were invited on the findings upto 15.10.2018. The details of the candidates found Eligible/Prov. Eligible/Not Eligible after examination of the objections is as under :-
