**RECRUITMENT TO THE POST OF CASHIER IN AIIMS RAIPUR ON REGULAR BASIS  
RESULT OF THE SKILL TEST AND FINAL RESULT**

Notice for recruitment to various Gr. 'B' and 'C' posts in AIIMS Raipur on regular basis was issued vide Admin/Rec./Regular/ Group 'B' & 'C'/2016/AIIMS.RPR/ dated 10.03.2016 which included 01-UR post of Cashier.

2. Computer Based Test (CBT) for recruitment to the post of Cashier along with other posts was conducted on 18.02.2017 and 19.02.2017.
3. List of shortlisted candidates for document verification & Skill Test on the basis of marks scored in CBT was declared vide Notice No. Admin/Rec./Regular /Group 'B' & 'C' / 2016/AIIMS.RPR/ dated 24.5.2017.
4. Shortlisted candidates were called for document verification and Skill Test vide notice dated 13.11.2017. Skill Test for the post of CASHIER was held in AIIMS Raipur on 24.12.2017 as per the following details :-

5. As per the provisions of the recruitment for above post, Skill Test is only Qualifying in nature and qualifying in skill test does not entail any right of appointment to the candidates. The competent authority at AIIMS Raipur has decided to keep the qualifying marks in Skill Test at 50% or more. Accordingly, the **result of the Skill Test for the post of Cashier is as under :-**

Only those candidates who have qualified in the Skill Test were considered for final selection and the same has been made on the basis of marks obtained by the qualified candidates in the Computer Based Test. Since there is only 01-UR vacancy against which only 01 candidate has qualified in the Skill Test, the **final select list** for the post of Cashier is as under :-

7. Further, candidate should note that his candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
