Advertisement for filling up **16 vacancies [UR-09; OBC-04; SC-02; ST-01] (including 01 vacancies for PwD)** of Nursing Officer (Staff Nurse Gr.II) was issued vide notice No. AIIMS-Rpr/Admin/Rec/AIIMS NAG /2018/0330 dated 24.09.2018.

2. Computer Based Test(CBT) was held on 14.11.2018 and the result of the CBT was declared on 26.12.2018. Shortlisted candidates were called for verification of document at AIIMS Nagpur on 07.01.2019. The eligibility status of candidates after verification of documents is as under:-
