- 5. Interview for the above mentioned posts is tentatively scheduled to be held in the month of August 2019. Exact dates of interview will be informed to the candidates in due course.
- 6. It may be mentioned that document verification of the candidates with regard to the age, educational qualification, experience etc has not been carried out before the written examination. All the candidates should note that their candidature for the post is purely PROVISIONAL. Shortlisting for interview does not entail them any right whatsoever for selection. Shortlisting of candidates has been made PROVISIONALLY on the basis of marks obtained in written examination. The verification of documents of the shortlisted candidates to ascertain that they fulfil all the eligibility conditions prescribed for the post will be done before the interview and only those candidates who fulfil the prescribed eligibility conditions for the post will be allowed to appear for the interview.
- Candidates should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post.
