30 vacancies of Technical Assistant were advertised. These vacancies were distributed equally for **Technical Assistant (MLT)**- 15 [UR-08; OBC-04; SC-02; ST-01] and **Technical Assistant (OT)**-15 [UR-08; OBC-04; SC-02; ST-01] including 01 PWD vacancy and separate examination was taken. Result of the Computer Based Test was declared on 20.05.2019 and shortlisted candidates were called for verification of their documents on 3.6.2019 and 4.6.2019. List of candidates' alongwith their eligibility status as per the recommendations of the Scrutiny Committee was uploaded on the website on 22.7.2019 and claims/objections were called from the candidates. Only 06 objections/claims were received by the due date. The Committee examined the claims and the final eligibility status of these 06 candidates is ANNEXED.

2. Only following 02 candidates have been found to fulfil the eligibility conditions for the post of **Technical Assistant (OT Techniques)**, hence they are recommended for appointment :-
