- Online bids are invited on behalf of Director, All India Institute of Medical Sciences (AIIMS), Raipur in two bid (Technical & Financial) system for "Annual Rate Contract for supply of Reagent Kits and Calibrators for Beckman Fully Automated Anayzers (AU Series)" for Department of Biochemistry at AIIMS Raipur. Manual bids shall not be accepted.
- 2. Tender document may be downloaded from AIIMS web site <u>www.aiimsraipur.edu.in</u> (for reference only) and CPPP site <u>https://eprocure.gov.in/eprocure/app</u> as per the schedule as given in CRITICAL DATE SHEET.
- 3. Bid shall be submitted online at CPPP website: <u>https://eprocure.gov.in/eprocure/app</u>.
- 4. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.
- 5. Tenderer who has downloaded the tender from the AIIMS web site www.aiimsraipur.edu.in and Central Public Procurement Portal (CPPP) eprocurement website https://eprocure.gov.in/eprocure/app shall not tamper/modify the tender form including downloaded price bid template in any manner. In case if the same is found to be tempered/ modified in any manner, tender shall be completely rejected and EMD would be forfeited and tenderer is liable to be banned from doing business with AIIMS Raipur.

The Technical bid should include the detailed specifications of main item/ equipment and its accessories. All items should be numbered as indicated in the **Annexure-I** (Any deviation should be clearly mentioned and supporting document should be submitted).

- 6. Manual bid shall not be accepted in any circumstance.
- 7. The complete bidding process in online bidding, Bidder should be possession of valid digital Signature Certificate (DSC) for online submission of bids. Prior to bidding DSC need to be registered on the website mentioned above.
- 8. Tenderers are advised to follow the instructions provided in the 'Instructions to the tenderer for the e-submission of the bids online through the Central Public Procurement Portal for e Procurement at <u>https://eprocure.gov.in/eprocure/app</u>'.
- 9. **Quotations should be valid for 180 days** from the tender due date i.e. tender opening date. The bidder should clearly indicate the period of delivery, Installation etc whichever is applicable.
- 10. Relevant literature pertaining to the items quoted with full specifications should be uploaded, where ever applicable.
- 11. Tenderer must provide evidence of having supplied government hospital/ reputed private hospital organizations in India similar nature of items of at least ₹25,00,000.00 of tender value in the last three years and the copy of the same should be uploaded.
- 12. The firm should be registered and should have the average annual turnover at least **₹50,00,000.00** of the bidder in the last three financial years. Copies of authenticated balance sheet for the past three financial years should be uploaded.

- 13. The tender document must be accompanied by copy of PAN, Certificate of firm/company registration, GST registration.
- 14. The quantity shown against each item is approximate and may vary as per demand of the Institute at the time of placement of order.
- 15. The bidder must be able to provide the product/ items within specified time period as prescribed in the Purchase Order, failing which the EMD will be forfeited. Furthermore on completion of the stipulated time period, Purchase Order will be cancelled and award will be given to another qualified bidder with the negotiated terms & conditions as per Institutes norms.
- 16. In the event of any dispute or difference(s) between the vendee (AIIMS Raipur) and the vendor(s) arising out of non-supply of material or supplies not found according to the specifications or any other cause what so ever relating to the supply or purchase order before or after the supply has been executed, shall be referred to the Director/AIIMS/Raipur who may decide the matter himself or may appoint arbitrator(s) under the arbitration and conciliation Act 1996. The decision of the arbitrator shall be final and binding on both the parties.
- 17. The place of arbitration and the language to be used in arbitral proceedings shall be decided by the arbitrator.
- 18. All disputes shall be subject to Raipur Jurisdiction only.
- 19. AIIMS Raipur reserves the rights to accept/ reject any bid in full or in part or accept any bid other than the lowest bid without assigning any reason thereof. Any bid containing incorrect and incomplete information shall be liable for rejection.
- 20. The Tender/ Bid will be opened on Store office at AIIMS Raipur Premises.
 - i) Only those financial bids will be opened whose technical bids are found suitable by the expert committee appointed for the concerned goods/ materials/ instrument/ equipment.
 - No separate information shall be given to individual bidders. In incomparable situation, the committee may negotiate price with the technically and financially qualified bidder before awarding the bid.
- 21. Copies of original documents defining the constitution or legal status, place of registration and principal place of business of the company or firm or partnership, etc.

22. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has bided the lowest evaluated quotation price.

- i) Not-withstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- ii) The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the bid validity period. The terms of the accepted bid shall be incorporated in the purchase order.
- 23. Rates should be quoted inclusive of packing, forwarding, postage and transportation charges etc.
- 24. The competent authority reserves all rights to reject the goods if the same are not found in accordance with the required description/ specifications/ quality.

- 25. Full description and specifications, make/ brand and name of the manufacturing firm must be clearly mentioned in the tender, failing which the tender will not be considered.
- 26. A brochure displaying clearly the product is to be attached with the tender if required.

27. Earnest Money:

Earnest money of **₹1,50,000.00** by means of a Bank Demand Draft/ FD, a scanned copy to be enclosed. It is also clarified that the bids submitted without earnest money will be summarily rejected. The DD/FD may be prepared in the name of "All India Institute of Medical Sciences, Raipur (AIIMS RAIPUR)". The used instrument must reach at officer of the Stores Officer Gate no. 5, Medical College Building, 2^{nd} Floor, AIIMS, Raipur before opening of tender.

- i) No request for transfer of any pervious deposit of earnest money or security deposit or payment of any pending bill held by the AIIMS Raipur in respect of any previous supply will be entertained. Tenderer shall not be permitted to withdraw his bid or modify the terms and conditions thereof. In case the tenderer fail to observe and comply with stipulations made herein or backs out after quoting the rates, the aforesaid amount of earnest money will be forfeited.
- ii) Tenders without Earnest Money or Tender cost will be summarily rejected.
- iii) No claim shall lie against the AIIMS Raipur in respect of erosion in the value or interest on the amount of EMD.
- iv) If MSME firm is registered for above tendered item, then the firm will be exempted for submission of EMD amount. Firm must upload scanned copy of following documents in support of exemption.

(1) National Small Industries Corporation (NSIC)

- v) The earnest money will be returned/refund to the unsuccessful tenderers after the tender is decided.
- vi) EMD should remain valid for a period of 45 days beyond the final bid validity period. When the tenderer agrees to extend the validity of bid, he shall also extend the validity of EMD suitably.
- 28. In case the supplier requires any elucidation regarding the tender documents, they are requested to contact to the Store Officer, AIIMS Raipur through **e-mail: store@aiimsraipur.edu.in** on or before end date of clarification as per critical date sheet.
- 29. The EMD of the successful bidder will be returned to them without any interest after the submission of Security deposit/ PSD.
- 30. Onsite demonstration will arrange by supplier as per requirement at their risk and cost; approved demonstrated item shall be kept till the completion of supply of item.
- 31. Other terms and condition applicable as per manual for procurement of goods 2017, GFR-2017 etc.

Other Terms & Conditions:

1. **Pre-Qualification Criteria:**

a. Bidder should be the manufacturer/authorized dealer/Distributor/Trader/ Supplier. Letter of Authorization from Manufacturer for the same and specific to the tender should be uploaded in the prescribed place.

2. <u>Performance Security Deposit:</u>

- a. The successful bidder shall have to submit a performance security deposit (PSD) within 30 days from the date of issue of Letter of Award (LOA). Extension of time for submission of PG beyond 30 days and up to 60 days from the date of issue of LOA may be given by the competent authority to sign the contract agreement however a panel interest of 15% per annum shall be charged for the delay beyond 30 days. i.e. 31st day after the date of issue of LOA. In case of the contract fails to submit the requisite PG even after 60 days from the date of issue of LOA the contract shall be terminated duly forfeiting other dues if any payable against the contract. The failed contractor shall be debarred from participating in re-tender (if any) for that item.
- b. Successful supplier/ firm should submit performance security deposit as prescribed in favour of "AIIMS, Raipur" and to be received in the Store Office, 2nd Floor, Medical College Building, Tatibandh, Raipur (C.G) Pin-492099 before the date of commencement of supply or 30 days from the date of acceptance of the purchase order, whichever is earlier. The performance security deposit to be furnished in the form of Bank Guarantee/DD/FD & Performance Security Deposit as per given Proforma of the tender documents, for an amount covering 10% of the contract value.
- c. The Performance Security Deposit (PSD) should be established in favour of "AIIMS Raipur" through any Schedule Bank with a clause to enforce the same on their local branch at Raipur.
- d. Validity of the performance security deposite shall be for a period of 60 days beyond of entire warranty period/rate contract from the date of issue of rate contract.
- 3. <u>Delivery</u>: The successful bidder should strictly adhere to the following delivery schedule supply should be effected within 45 days from the date of purchase order and this clause should be strictly adhere to failing which administrative action as deemed fit under rules will be taken against the defaulter. Otherwise Liquidation Damages will be imposed as per clause no. 4. Purchase order will be placed as required by consignee.
- 4. <u>Penalty:</u> If the suppliers fails to deliver and place any or all the items or perform the service by the specified date as mention in purchase order, penalty at the rate of 0.5% per week of delayed value of goods subject to the maximum of 10% of delayed goods value will be deducted, afterwards another penalty may be imposed.
- 5. <u>**Right of Acceptance:**</u> AIIMS, Raipur reserves the right to accept or reject any or all tenders/quotations without assigning any reason there of and also does not bind itself to accept the lowest quotation or any tender. AIIMS, Raipur also reserves the rights to accept all the goods/equipment/instruments in the given tender or only part of it in any given schedule without assigning any reason.
- 6. <u>**Training and Demonstration**</u>: Suppliers need to provide adequate training and demonstration at AIIMS Raipur to the nominated person of AIIMS Raipur at their cost. AIIMS Raipur will not bear any training or living expenditure in this regard. The Supplier should arrange for regular weekly visit to the AIIMS, Raipur campus by its technical team and assist in maintenance of the item/equipment within warranty period. Assistance limited to locking companies with manufacturer will not be considered sufficient.

7. <u>Validity of the bids</u>: The bids shall be valid for a period of 180 days from the date of opening of the tender. This has to be so specified by the tenderer in the commercial bid which may be extended, if required.

8. Risk Purchase & Recovery of sums due:

- Failure or delay in supply of any or all items as per Requisition/ Purchase Order, Specification or Brand prescribed in the tender, shall be treated as 'non compliance' or 'breach of contract' and the order in part of full be arranged from alternative source(s) at the discretion of the hospital authority and the difference in price has to be recovered from the tenderer as mentioned elsewhere.
- The amount will be recovered from any of his subsequent/ pending bills or security Deposit.
- In case the sum of the above is insufficient to cover the full amount recoverable, the contractor shall pay to the purchaser, on demand the remaining balance due.
- 9. <u>Communication of Acceptance:</u> AIIMS, Raipur reserves all right to reject any tender including of those tenderers who fails to comply with the instructions without assigning any reason whatsoever and does not bind itself to accept the lowest or any specific tender. The decision of this Institute in this regard will be final and binding.
- 10. <u>Insolvency etc.</u>: In the event of the firm being adjudged insolvent or having a receiver appointed for it by a court or any other under the Insolvency Act made against them or in the case of a company the passing any resolution or making of any order for winding up, whether voluntary or otherwise, or in the event of the firm failing to comply with any of the conditions herein specified AIIMS, Raipur shall have the power to terminate the contract without any prior notice.
- 11. **Extension:** The rate contract is initially for **one year** and may be re-considered / extended up to a further period of **one year** by annually after the satisfactory performance with mutual consent with same price. However, the decision of the Director, AIIMS Raipur shall be final in this regard.
- 12. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, exception, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) provided notice of happening of any such eventuality is given by party to other within 21 days from the date of occurrence thereof, neither party hall by reason of such event be entitled to terminate this contract nor shall either party have any claim for damages against other in respect of such non-performance or delay in performance and deliveries have been so resumed or not shall be final and conclusive.

Further, that if the performance in whole or in part of any obligation under this contract is prevented or delayed by reason of any such event for a period exceeding 60 days, AIIMS, Raipur party may, at least option to terminate the contract.

- 13. **Breach of Contract:** In case of breach of any terms and conditions as mentioned above, the Competent Authority, will have the right to cancel the contract without assigning any reasons thereof and nothing will be payable by AIIMs, Raipur. In that event the security deposit shall also stand forfeited.
- 14. <u>Subletting of contract:</u> The firm shall not assign or sublet the contract or any part of it to any other person or party without having first obtained permission in writing of AIIMS, Raipur, which will be at liberty to refuse if thinks fit. The tender is not transferable.
- 15. <u>Right to call upon information regarding status of contract</u>: The AIIMS, Raipur will have the right to call upon information regarding status of contract at any point of time.

16. Terms of payment:

16.1 Payment shall be made subject to recoveries, if any, by way of liquidated damages or any other charges as per terms & conditions of contract in the following manner.

The payment would be made for actual supply taken and no claim in this regard should be entertained. 100% payment will be made on receiving of goods in store satisfactorily with approved quality and ordered quantity and upon the submission of the following documents:

- i) Four copies of supplier's invoice showing contract number, goods description, quantity, unit price and total amount with revenue stamp.
- ii) Two copies of packing list identifying contents of each package.
- iii) Consignee receipt certificate in original issued by the authorised representative of the consignee
- **16.2** PO shall be placed as per requirement and 100% payment against receipt and acceptance of material to be made against each PO.
- 16.3 No claim will be entertained regarding interest on any payment.
- **16.4** Where there is a statutory requirement for tax deduction at source, such deduction towards income tax and other tax as applicable will be made from the bills payable to the Supplier at rates as notified from time to time.
- **16.5** No payment shall be made for rejected stores. Rejected equipment's must be removed by the supplier within two weeks of the date of issue of ejection advice at their own cost & replace immediately. In case these are not removed these will be auctioned at the risk, cost and responsibility of the suppliers.
- 17. <u>Arbitration:</u> If any difference arises concerning this agreement, its interpretation on payment to the made there under, the same shall be settled out by mutual consultation and negotiation. If attempts for conciliation do not yield any result within a period of 30 days, either of the parties may make a request to the Director, AIIMS Raipur to settle the dispute by Sole Arbitrator. Sole arbitrator will be appointed by the Director, AIIMS Raipur. In case of such arbitrator refusing, unwilling or becoming incapable to act or his mandate having been terminated under law, another arbitrator shall be appointed in the same manner from among the panel of three persons to be submitted by the claimant. The provision of Arbitration and Conciliation Act, 1996 and the rule framed there under and in force shall be applicable to such proceedings.
- 18. <u>Legal Jurisdiction:</u> The agreement shall be deemed to have been concluded in Raipur, Chhattisgarh and all obligations hereunder shall be deemed to be located at Raipur, Chhattisgarh and Court within Raipur, Chhattisgarh will have Jurisdiction to the exclusion of other courts.
- 19. **Option Clause**: Under this clause, the purchaser retains the right to place order for an additional quantity up to a 25-30% of the originally contracted quantity at the same rate and terms of the contract, during the currency of the contract.
- 20. GST Clause: GST rates applicable on your quoted item may please be confirmed.

Please confirm if there any change (Upward/Reduction) in your **Basic Price** structure. And you are also requested to pass the Input Credit as per the following **Anti Profitering Clause** of GST. **"Upon Implementation of GST, any reduction in the rate of tax on supply of goods or service** or the benefit of input tax credit shall be passed on to AIIMS Raipur by way of commensurate reduction in the prices"

21. Fall Clause :

- 1. Prices charged for supplies under Rate Contract by the supplier should in no event exceed the lowest prices at which he bids to sell or sells the stores of identical description to any other State Government/ Public Undertaking during the period of the contract.
- 2. If at any time during the period of contract, the prices of tendered items is reduced or brought down by any law or Act of the Central of State government, the supplier shall be bound to inform Purchasing Authority immediately about such reduction in the contracted prices, in case the supplier fails to notify or fails to agree for such reduction of rates, the Purchasing authority will revise the rates on lower side. If there is a price increase for any product after quoting the rates, the bidder will have to supply the item as per quoted rates. This office will not accept any higher rates after wards.
- 3. If at any time during the period of contract, the supplier quotes the sale price of such goods to any other State Govt. and Pubic Undertakings at a price lower than the price chargeable under the rate contract he shall forthwith notify such reduction to Purchasing Authority and the prices payable under the rate contract for the equipment's supplied from the date of coming into force of such price stands correspondingly reduced as per above stipulation.

Any deviation in the material and the specifications from the accepted terms may liable to be rejected and the suppliers need to supply all the goods in the specified form to the satisfaction/ specifications specified in the Purchase order and demonstrate at the their own cost.

- 22. False declaration will be in breach of the code of integrity under Rule 175 (1) (i) (b) of the General Financial Rules for which a bidder or its successors can be debarred for up to two years as per Rule 151 (iii) of the General Financial Rules along with such other action as may be permissible under law.
- 23. L1 will be decided based on the lowest cost per test in total for all parameters as listed.

SPECIFICATIONS AND TENDER TERMS FOR LABORATORY REAGENTS (KITS) AND CHEMICALS FOR BECKMAN COULTER AUTOANALYZER (AU PLATFORM)

- 1. Laboratory reagents (kits) and chemicals should be bar coded and readable, dedicated system packs, easy to fit and compatible with Beckman Coulter Autoanalyzer (AU platform: Models AU5811, AU680, AU480)
- 2. The reagent positioning and method specific programming should be automatic.
- 3. There should be option for multi-switching of reagents i.e. more than one reagent bottle for same parameter can be positioned at a time so that once the primary reagent is used up the machine can directly switch to the standby reagent.
- 4. The pack size should be the smallest available.
- 5. Kits should have long stability and have long expiry (at least eight months from the date of supply of kits to the Institute)
- 6. Products and reagent should be original packing of the manufacturer and not refilled.
- 7. Instrument specific application sheet and kit evaluation certificate for each parameter in the above mentioned autoanalyzer, should be available inside the kit and should be submitted along with the technical bid. Original product literature of Manufacturer having all details of

the test should be provided along with the technical bid which should include normal range, LOD, linearity, reproducibility, on board reagent stability, calibration frequency, expiry date and interference in assay etc.

- 8. Performance certificate and/or recommendation letters from three government institutions mentioning their reagents were found compatible and are being used satisfactorily in the above mentioned Beckman Coulter platform for a minimum period of three years. The name of the certifying/recommending person with designation and contact details need to be mentioned.
- 9. Single reagent testing would be preferred, but should not have more than two reagents in any case.
- 10. Traceability certificates for controls and calibrators should be submitted along with the technical bid.
- 11. Normal reference range of different analytes for the AU series, AU480, AU680 and AU5811 should be mentioned in the product literature.
- 12. Declaration that the technical support will be provided from the company to resolve the queries for instrument application, QC interpretation, calibration issues. Reagents and result related issues.
- 13. Downtime of not more than 5hrs is must for the company, providing technical support and should be based in Raipur, Chhattisgarh.
- 14. Quantity of kits required per year will vary. The need will depend on the patient load and reagent consumption. However the kits have to be stocked with the dealers/suppliers based in Raipur, Chhattisgarh, who may be asked to provide the same at short notices, not exceeding 72hrs. The detail stock of each parameter to be kept at the distributor level should be discussed with the department intermittently.
- 15. L1 bidder will be decided based on the lowest cost per test in total for all the parameters as listed. Bidder must quote for all the items (1- 26) to be considered eligible.
- 16. Committee may reject the bidder, if the provided kits are not submitted within the time limit or if submitted of substandard quality.
- 17. Successful bidder has to supply the mentioned reagents within six week of receipt of purchase order.

Instructions for Online Bid Submission:

The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

More information useful for submitting online bids on the CPP Portal may be obtained at: https://eprocure.gov.in/eprocure/app.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: https://eprocure.gov.in/eprocure/app) by clicking on the link "Online bidder Enrollment" on the CPP Portal which is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / nCode / eMudhra etc.), with their profile.
