- 5) After expiry of delivery Period material cannot be accepted without the extension of delivery period.
- 6) GST rates applicable on your quoted item may please be confirmed. HSN code for each item shown be clearly mentioned.
- 7) Please confirm if there any change (Upward/Reduction) in your Basic Price structure.
