### DOCUMENT VERIFICATION OF CANDIDATES AFTER ANNOUNCEMENT OF 2<sup>ND</sup> ROUND OF SEAT ALLOCATION OF NORCET-2022 FOR RECRUITMENT TO THE POST OF NURSING OFFICER AT AIIMS RAIPUR

This is with reference to AIIMS, New Delhi recruitment Notice No. 115/2022 dated 04.08.2022 regarding recruitment to the post of Nursing Officer on 'Direct Recruitment' basis in various AIIMS through NORCET-2022 and Result Notification No. 50/2023 dated 13.04.2023 regarding announcement of 2<sup>nd</sup> Round of seat allocation of NORCET-2022.

2. All the candidates of NORCET-2022 who have allocated AIIMS Raipur after announcement of 2<sup>nd</sup> Round of Seat Allocation and have uploaded their documents on the NORCET-2022 portal, as mentioned in the result notification dated 13.04.2023 of AIIMS New Delhi, are hereby informed that their document verification will be conducted in **ONLINE** mode i.e. through the NORCET-2022 portal of AIIMS, New Delhi. Hence, **these candidates are not required to be present in person for their document verification.** List of these candidates, as received from AIIMS, New Delhi, are annexed at **Annexure A**.

3. After verification of documents submitted by the candidates in support of their eligibility, a list of Eligible/Ineligible/Provisionally Eligible candidates shall be published on the website of AIIMS Raipur shortly.

4. Since the document verification will be conducted online (from NORCET-2022 portal), clarification, if any, from candidates regarding validity/correctness of their documents etc. will be communicated through registered email ID of the candidates. Such candidates must reply/submit necessary documents within the specified dates **if asked by AIIMS Raipur**. As already informed by AIIMS, New Delhi vide Result Notification No. 50/2023 dated 13.04.2023, failure to provide the requisite information/documents may lead to cancellation of candidature for which the concerned candidate will only be responsible. Hence, candidates are advised to regularly check their registered email ID.

5. AIIMS Raipur reserves the right to cancel the candidature of candidate in case of failure in submission of document in support of his/her eligibility for the post and also to amend the schedule of document verification, as per the requirement of the Institute.
