3. Scrutiny of applications and documents submitted by candidates belonging to the above-mentioned department was carried out by the Scrutiny Committee. 4. 6. Any claim/objection/representation regarding eligibility status received after the prescribed date will not be entertained.

7. The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final eligibility status of candidates will be published on the website of AIIMS Raipur in due course.

Note:
