This in reference to advertisement No Admin/Rec./Regular/Group 'A'/11/2017/AIIMS.RPR/2103, Dated 28.11.2017 and Notice No. Admin/Rec./Regular/Group 'A'/11/2017/AIIMS.RPR/113, Dated 03.07.2018 for recruitment of various Group A posts on direct recruitment basis at AIIMS, Raipur.

It is to inform that, due to some administrative reasons the interview for recruitment to the post of **Accounts Officer**, which was scheduled on **07th July 2018** at 10:00 AM, in the premises of AIIMS, Raipur has been **cancelled**.

In view of large number of candidates competent authority has been decided to conduct written examination for the post of Accounts Officer. Syllabus, Scheme of Examination and Date of examination will be notified in the website of AIIMS, Raipur in due course.

If any provisionally eligible and in-eligible candidate for the post of Accounts Officer has any objection /clarification regarding his/her eligibility, he/she may send their objection/ clarification along with relevant documents to recruitment@aiimsraipur.edu.in and subsequently send the same by Speed Post /Registered Post to Sr. Administrative Officer, AIIMS, Tatibandh, Raipur (C.G.) Pin 492099, which should reach the above said address by **20-07-2018**. The objections/ clarifications received after **05:00 PM on 20-07-2018** will not be entertained.

The candidates may also report personally along with all supporting documents (in original and a self attested copy of these documents) in favour of their candidature from 04-07-2018 to 20-07-2018 between 11:00 AM to 5:00 PM (on working days) to Sr. Administrative Officer, AIIMS Raipur, Tatibandh, Raipur. No TA/DA shall be provided for this purpose.

The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently admit cards for appearing in the written examination will be issued to these candidates only if they are found eligible by the Scrutiny Committee.

For other posts (Ante-Natal Medical Officer, Blood Transfusion Officer, Deputy Medical Superintendent and Senior Dietician (Assistant Food Manager), If any in-eligible/provisionally eligible candidate has any objection/clarification regarding his/her eligibility, he/she may represent his/her objection/clarification in front of Scrutiny Committee along with relevant documents mentioned in Annexure-I on the date of interview i.e. 07th July 2018 between 08:00 A.M. to 09:00 A.M.
