If there is any discrepancy in the admit card then the candidates are advised to report personally on **one day before the conduct of examination** at the Facilitation Counter operational between 10:00 AM to 12:00 Noon at AIIMS Medical College Building, Recruitment Cell, 3rd Floor, Gate No. 5, Tatibandh, GE Road, Raipur, Chhattisgarh along with 2 passport size photographs and related documentary evidence/certificates etc. for issuance of duplicate Admit Card/Roll Number.
