Reference is to the advertisement No. Admin/Rec./Regular/Group 'B'/2017/AIIMS.RPR/966, Dated 27.07.2017 inviting online applications for recruitment to the post of **Maternity and Child Welfare Officer**, **Health Educator** (Social Psychologist) and Junior Reception Officer on direct recruitment basis in AIIMS Raipur. List of shortlisted candidates was published vide Notice No. 5/2/2018-Rectt. AIIMS.Rpr, Dated 27.07.2018.

Document verification for above mentioned post was scheduled on 10.08.2018 & 11.08.2018 in the premises of AIIMS, Raipur vide Notice No. Admin/Rec./Regular/Group 'B'/2017/AIIMS.RPR/224 Dated 01.08.2018. During the document verification candidates who were not having relevant documents has declared Provisionally Eligible by the Scrutiny Committee and undertaking was obtained from that candidates to submit the relevant documents within 07 days from the date of document verification, after the receiving of relevant documents, applications scrutinized by the scrutiny committee.

The candidates may also report personally along with all supporting documents (in original and a self attested copy of these documents) in favour of their candidature from **23.05.2019** to **29.05.2019** between 11:00 AM to 5:00 PM (on working days) to Recruitment Cell, 3<sup>rd</sup> Floor, Medical College Building, Tatibandh, AIIMS Raipur, Raipur (C.G.) Pin-492099. No TA/DA shall be provided for this purpose.

The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final result will be declared.

Candidates should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.
