## NOTICE REGARDING RECRUITMENT TO THE POST OF TECHNICAL ASSISTANT/ TECHNICIAN (OT TECHNIQUES/MEDICAL LAB TECHNOLOGY) ON DIRECT RECRUITMENT BASIS IN AIIMS RAIPUR

Reference is to the advertisement Admin/Rec./Regular/Group 'B' & 'C'/2016/AIIMS.RPR, Dated 10.03.2016 inviting online applications for recruitment to the post of Technical Assistant/Technician on direct recruitment basis in AIIMS Raipur. The result of the CBT was declared vide Notice No. 5/1/2017-Rectt. AIIMS.Rpr, Dated 20.05.2019.

Document verification for above mentioned post was scheduled on 03.06.2019 and 04.06.2019 in the premises of AIIMS, Raipur vide Notice No. Admin/Rec./Regular/Group 'B'/2017/AIIMS-RPR/976, Dated 23.05.2019. During the document verification candidates who were not having relevant documents has declared Provisionally Eligible by the Scrutiny Committee and undertaking was obtained from that candidates to submit the relevant documents within 07 days from the date of document verification, after the receiving of the documents a scrutiny committee was constituted to re-scrutinize all the applications of shortlisted candidates.

The candidates may also report personally along with all supporting documents (in original and a self attested copy of these documents) in favour of their candidature from **22/07/2019** to **31/07/2019** between 11:00 AM to 5:00 PM (on working days) to Recruitment Cell, 3<sup>rd</sup> Floor, Medical College Building, Tatibandh, AIIMS Raipur, Raipur (C.G.). No TA/DA shall be provided for this purpose.

The objections/clarifications submitted by the candidates will be scrutinized by the Scrutiny Committee and subsequently final result will be declared.

Candidates should note that their candidature is purely PROVISIONAL at all stages of recruitment and subject to fulfilling all the eligibility criteria prescribed for the post. The candidature of the candidate is liable to be cancelled by the Competent Authority in AIIMS Raipur if at any stage of their appointment it is found that he/she does not fulfill any of eligibility criteria or conditions or if he/she does not belong to the category claimed or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection to the respective post.

After declaration of final result and before joining of the candidate in the institute, all certificates which are provided by the candidate may be sent for the police verification and if the same found <u>fake/tempered/false</u>, **candidature of the candidate will be cancelled also the** <u>legal action will be taken against the candidate and issuing authority of the certificate.</u>
