**TERMS & CONDITIONS:-**

1. Quotation should be submitted with the proof of eligibility.
2. All the material, equipment, labour and safety arrangement etc. will be arranged by the contractor. Nothing will be issued by the department.
3. Work is of urgent nature and should be continue for **One (01) Year** after award of work.
4. The work shall be carried out as per CPWD specification with upto corrections slips and terms and conditions of work order.
5. Agency shall comply the labour rules.
6. All statutory taxes deduction shall be made as per provisions.
7. It shall be the responsibility of the contractor for safety and cleanliness of the Equipment's particularly which are under his sole possession/ use as reqd. Nothing extra shall be paid to the contractor in this regard.
8. Rates are included of all prevailing taxes and duties. Nothing extra should be paid in this regard.
9. Any damage done to the existing installation/building particularly due to negligence shall be entire responsibility of contractor to make good the same free of cost.

10. The contractor shall provide identity card to the staff employed at site. The staff deputed at site of work shall be trained & qualified as per the CPWD manual and should be able to behave properly with occupants. In case complaint about any misbehavior & / or of improper working of any of staff of contractor is received/ noticed the concerned person shall be presumed that no such staff was on duty beside taking any other suitable action by Engineer-in- Charge as deemed fit.
11. The Contractor shall be responsible to provide & maintain records at site of work e.g. for attendance of on duty staff, log books for equipment's etc. as required.
12. Cleaning agents, such as soap & dusters shall be provided by the contractor nothing extra shall be paid for such items.
13. The department will not pay beyond and above the quoted rates in respect of provident fund, Gratuity, paid Holiday, Weekly off, Relieving charges, Medical Charges, Insurance Charge etc.
14. The department will not be responsible for any injury sustained by the agency workers during the performance of their duties and also for any damages or compensation due to any dispute between the agency and its workers. Any expenditure incurred by the department to face the situation arising out of act of his workers will be paid by the Agency. The Agency will be fully responsible for the payment of compensation.
15. The Contractor/ Agency shall be responsible for the conduct behavior and Fidelity of the staff employed by him.
16. The Engineer in-Charge reserves the right to extend/ reduce the period of contract. Extra for increase in labour wages (if any) shall be paid for extended period.
17. Labour engaged by the contractor shall not be paid less than the minimum wages as fixed by the Government from time to time.
18. The Contractor shall examine periodically all safety devices and make the customary annual safety test as require by local certified authority and Engineer In-charge.
19. The contractor shall also renew all wire ropes as necessary to maintain as a factor of safety to equalize the tension in all lifting ropes and repair or replace conductor cable.
20. Lifts are to be regularly & systematically examined, adjusted & lubricated due to normal wear & tear or replaced without any extra charges.
21. No T&P would be issued by the department.
22. Final decision for approving the material rests with the Engineer-in-charge.
23. Contractor has to provide dedicated mobile number and Email ID for any complaints regarding Kone Lifts installed at AIIMS Complex, Raipur.
24. In case of non-compliance with the contract, the "Client" reserves its right to impose the penalty @ 0.5% of contract value per week will be deducted subject to maximum up to 5% of contract value if contractor has failed to rectify the problem within downtime period and entered into contract on your risk and cost in case of default.
