Instructions to bidder:

- The percentage rates are to be quoted in words and figures inclusive all taxes GST, octroi, transportation etc. (Nothing to be paid extra on this account).
- The Bidders shall have to submit original instrument for EMD before the last date of opening of quotation to the office of Tender Opening Authority. The bid security is to remain valid for a period of **45 (forty-five) days** beyond the final bid validity period. Bid security will be refunded to the successful bidder after completion of work. Bid securities of the unsuccessful bidders should be returned at the earliest after expiry of the final bid validity period and latest by the 30th day after the award of work order.

A bidder's bid security will be forfeited if the bidder:

- withdraws or amends its/ his tender;
 - impairs or derogates from the tender in any respect within the period of validity of the tender;
 - If the bidder does not accept the correction of his bid price during evaluation.
- The bid for the works shall remain open for acceptance for a period of **45 days** from the date of opening of quotation/bid.
 - Goods and services Tax (GST)**
 - GST Registration Certificate of the State in which the work is to be taken up, if already obtained by the bidder.

- (ii) If the bidder has not obtained GST registration in the State in which the work is to be taken up, or as required by GST authorities then in such a case the bidder shall scan and upload following under taking along with other bid documents.

“If work is awarded to me, I/we shall obtain GST registration Certificate of the State, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by AIIMS, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by AIIMS or GST department in this regard.

5. Signing of application and bid:

- a) If the bidder is an individual, the application / bid shall be signed by him above his full type written name and current address.
- b) If the bidder is a proprietary firm, the application / bid shall be signed by the proprietor above his full type written name and the full name of his firm with its current address.
- c) If the bidder is a firm in partnership, the application / bid shall be signed by all the partners of the firm above their full type written names and current addresses, or, alternatively, by a partner holding power of attorney for the firm. In the later case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
- d) If the bidder is a limited company or a corporation, the application / bid shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The bidder should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.

6. Security Deposit @2.5% of quoted value will be deducted & will be released after 06(Six) months of successfully completion of work.
7. Specifications to be followed for execution of work as per latest CPWD E&M Specifications correction slips up to date and direction of the Engineer-In Charge.
8. The **first and final bill** payment will be done after completion of work as per specification.
9. Labour Law to be obeyed by the Agency.
10. **Certificate of Registration for GST, Enlistment order of contractor** should be attached with Quotation which is duly self attested.
11. Time allowed for the completion of the **work is 10 Days**. It will be reckoned from the day award of the work.
12. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
13. The Contractor shall remove from site all rubbish and debris generated by the Works and keep Works clean and tidy.

14. All damages done to the building during execution of work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-Charge. Any expenditure incurred by the department in this condition shall be recovered from the contractor and decision of the Engineer-in-Charge about recovery shall be final.
15. The work will be done in a running hospital, hence the work to be done as per the rules and instructions of Engineer-In-Charge. All the conditions of work at site are applicable to the successful bidder.
