Terms & Conditions:

1. The **percentage rates** are to be quoted in words and figures inclusive all taxes octroi, transportation etc. (Nothing to be paid extra on this account).
2. EMD Rs. 3,700.00 has to be deposited in form of DD/FDR/BG in favor of **AIIMS Raipur** with quotation. In case the lowest bidder refuses to execute the work, EMD will be forfeited. EMD will be retained of successful bidder and will be released after successful completion of work.
3. **Security Deposit @2.5%** of quoted value will be deducted & will be released after 06(Six) months of successfully completion of work.
4. Specifications to be followed for execution of work as per CPWD Specifications-2019 and direction of the Engineer-In Charge.
5. The **first and final bill** payment will be done after completion of work as per specification.
6. Labour Law to be obeyed by the Agency.
7. **Certificate of Registration for GST, Contractors' registration** should be attached with **Quotation and duly seal & sign on each document**.
8. **Time allowed for the completion of the work is 30days**. It will be reckoned from the day award of the work.

9. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
10. The Contractor shall remove from site all rubbish and debris generated by the Works and keep Works clean and tidy.
11. All damages done to the building during execution of work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-Charge. Any expenditure incurred by the department in this condition shall be recovered from the contractor and decision of the Engineer-in-Charge about recovery shall be final.
12. Bidders are suggested to visit the site with Junior Engineer(C), Er. Amarnath Chandra before participating in the quotation.
13. The work will be done in a running hospital, hence the work to be done as per the rules and instructions of Engineer-In-Charge. All the conditions of work at site are applicable to the successful bidder.
14. **Method of application:**
 - a) If the bidder is an individual, the application shall be signed by him above his full type written name and current address.
 - b) If the bidder is a proprietary firm, the application shall be signed by the proprietor above his full type written name and the full name of his firm with its current address.
