

#### **Conditions:**

- 1. The **percentage rates** are to be quoted in words and figures inclusive all taxes octroi, transportation etc. (Nothing to be paid extra on this account).
- 2. EMD **Rs.** 5,000.00 has to be deposited in form of DD/FDR/BG in favor of AIIMS Raipur with quotation. In case the lowest bidder refuses to execute the work, EMD will be forfeited. EMD will be retained of successful bidder and will be released after successful completion of work.
- 3. Specifications to be followed for execution of work as per CPWD Specifications-2009 Vol-1 & Vol-II and direction of the Engineer-In Charge.
- 4. The first and final bill payment will be done after completion of work as per specification.
- 5. Labour Law to be obeyed by the Agency.
- 6. Certificate of Registration for GST, Contractors' registration should be attached with Quotation and duly seal & sign on each documents.
- 7. **Time allowed for the completion of the work is 60 days**. It will be reckoned from the day award of the work. **If work is not completed within specified time period then EMD will be automatically forfeited**.
- 8. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.



- 10. All damages done to the building during execution of work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-Charge. Any expenditure incurred by the department in this condition shall be recovered from the contractor and decision of the Engineer-in-Charge about recovery shall be final.
- 11. Bidders are suggested to visit the site with Junior Engineer(C) Er. Ayush Vyas before participating in the quotation.
- 12. Signing of Application/bid:
- a) If the bidder is an individual, the application/bid shall be signed by him above his full type written name and current address.
- b) If the bidder is a proprietary firm, the application/bid shall be signed by the proprietor above his full type written name and the full name of his firm with its current address.
- c) If the bidder is a firm in partnership, the application/bid shall be signed by all the partners of the firm above their full type written names and current addresses, or, alternatively, by a partner holding power of attorney for the firm. In the later case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
- d) If the bidder is a limited company or a corporation, the application/bid shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The bidder should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.
