#### Conditions:

1. Labour Law to be obeyed by the Agency.
2. **Time allowed for the completion of the work is 06 months.** It will be reckoned after the day award of the work.
3. **The work order may be terminated at any time by giving notice of 07 days by the department in case of non-requirement of the service.**
4. **EMD will be converted into performance guarantee of lowest bidder and will be released after successful completion of work.**
5. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
6. **No mobilization advance** will be allowed.
7. **EMD/PG will be forfeited if performance will not be achieve satisfactory by the bidder.**
8. Log book will be maintained by the agency and duly verified by the Engineer of the Project Cell.
9. Required skilled manpower for 24 hours (three shifts) will be provided to mobilize DG Set, Connect the cable, start DG set.
10. In case of DG breakdown agency has to rectify DG Set or replace DG set in 24 hours.
11. DG Set if not operated in time there will be penalty of Rs. 5000.00 per hour.
12. Work to be started in 3 days after issue of work order otherwise a penalty of Rs. 2000.00 per day will be imposed.

13. Payment will be done on monthly basis.
14. Safety and Security of DG Set will be responsibility of agency.
15. Work has to be done as per CPWD (E/M) specification and CPWD Works Manual 2014 and as per direction of Engineer- In-charge.
16. Any permission for running DG Set from state authorities required to be arrange by agency.
17. As it is electrical work guidelines of electricity rules 1956, electrical act 2010 to be followed during execution of work.
18. The agency has to available 500 liter HSD at the time of the first operation and the rate will be deemed to be inclusive in the rate quoted by the agency. Beyond 500 liter HSD the diesel will be supplied by AIIMS Raipur. After completion of the work the remaining diesel in the fuel tank will be returned by the contractor to AIIMS Raipur.
19. The work will be done in a running hospital, hence the work to be done as per the rules and instructions of Engineer-In-Charge. All the conditions of work at site are applicable to the successful bidder.
20. Except diesel all materials such as lubricant oil etc. will be the part of agency and the cost is deemed to be included in item.
