- 1. The **Item rates** are to be quoted in words and figures inclusive all taxes octroi, transportation etc. (Nothing to be paid extra on this account).
- Security Deposit @ 2.5% of quoted value will be deducted & will be released after 06 (Six) months of successfully completion of work.
- 3. Liquidated damages @ 0.5% of quoted value per week will be deducted for delay of work subject to maximum up to 10% of quoted value.
- 4. The work will be executed as per directions of the Engineer-In Charge.
- 5. Time allowed for the **completion of the work** is **15 days**. It will be reckoned from the day award of the work.
- 6. Unless otherwise provided in the Schedule of quantities, the rates tendered by the contractor shall be all inclusive and shall apply to all heights, lifts, leads and depths of the building and nothing shall be payable to him on this account.
- 7. The first and final bill payment will be done after completion of work as per specification.
- 8. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.

- 9. The Contractor shall remove from site all rubbish and debris generated by the Works and keep Work site clean and tidy.
- 10. All damages done to the building during execution of electrical work shall be the responsibility of the contractor and the same will be made good immediately at his own cost to the satisfaction of the Engineer-in-Charge. Any expenditure incurred by the department in this condition shall be recovered from the contractor and decision of the Engineer-in-Charge about recovery shall be final.
