The Superintending Engineer (Civil), AIIMS, Raipur on behalf of Executive Director, AIIMS, Raipur invites online **Item Rate bids in two bid system (Technical cum Eligibility Bid & Financial Bid)** from eligible Structural Designers for the following work(s):-

Terms & Conditions:

- 1. The **first and final bill** payment will be done within 30 days after submission of architectural and structural drawing and design duly vetted by Government Engineering College of Chhattisgarh/ NIT/IIT
- 2. The structural designer shall be solely responsible for the drawing and design submitted. The structural designer shall perform all necessary tests required prior to preparation of drawing and design at their own cost and nothing in this regard shall be reimbursed or paid by AIIMS Raipur.

- 3. Item Rate Schedule of Quantity attached in CPP Portal.
- 4. Time allowed for the final submission after issue of work order shall be 45 days. It will be reckoned from the date of issue of work order.
- 5. EMD will be forfeited if the work is not completed in stipulated time.
- 6. EMD amount will be released to the successful bidder if work is completed within the stipulated date of completion.
- 7. The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services and tests required for the work.
- 8. Bidders are suggested to visit the site in AIIMS Raipur before participating in the online e-quotation. Post submission of bid, it is deemed that the bidder have visited the site and no further claim in this regard shall be admissible.

Information to the bidders:-

- 1. The intending bidders must have valid class-III digital signature to submit the bid. Manual bid shall not be accepted in any circumstance. The complete bidding process is online bidding; Bidder should have valid digital Signature Certificate (DSC) for online submission of bids.
- 2. The bid document consisting of the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website http://eprocure.gov.in/eprocure/appfree of cost.
- **3.** The bid can be submitted only after uploading the mandatory scanned documents up to 100 dpi Copies of eligibility documents and EMD as specified on the e-tendering website within the period of tender submission. Bidders can upload documents in the form of JPG format, PDF format and any other format as permissible by the e-tendering portal.
- **4.** Bidders must ensure to quote rate of each item. If any cell is left blank the same shall be treated as "0". Therefore, If any cell is left blank and no rate is quoted by the bidder, rate of such item shall be treated as "0"(ZERO). After submission of the bid online the contractor can re-submit revised bid any number of times but before last time and date of submission of bid as notified.
- **5.** After submission of bid online, it can be revised any number of times before specified time on last date of submission of bid. While submitting the revised bid, bidder can revise the rate of one or more item(s) any number of times (need not re-enter rate of all the items) but before last time and date of submission of bid as notified.
- **6.** Financial bids shall be opened online only for bidders for whom EMD and other uploaded documents are found in order and who are found to be eligible to bid for work. On opening date, the bidder can log in and see the bid opening process. After opening of bid he/she will receive the competitor bid sheets.
- **7.** If the bidder is found ineligible after opening of bid, bid shall become invalid.
- 8. The Bidders shall have to submit original instrument for EMD on or before the last date of opening of TECHNICAL Cum Eligibility Bid to the office of Tender Opening Authority. The bid security in form of EMD is to remain valid for a

period of 45 (forty-five) days beyond the final bid validity period. Bid securities of the unsuccessful bidders should be returned at the earliest after L1 decided by Committee of AIIMS Raipur.

- **9.** The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criteria.
- 10. Intending Bidders are advised to inspect and examine the site and its surroundings and satisfy themselves before submitting their bids, the means of access to the site, the accommodation they may require and in general shall themselves obtain all necessary information as to risks, contingencies and other circumstances which may influence or affect their bid. A bidder shall be deemed to have full knowledge of the site whether he inspects it or not and no extra charge consequent on any misunderstanding or otherwise shall be allowed. The bidders shall be responsible for arranging and maintaining at his own cost, all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work unless otherwise specifically provided for in the contract documents. Submission of a bid by a bidder implies that he has read this notice and all other contract documents and has made himself aware of the scope and specifications of the work to be done and of conditions.
- **11.** The Bid paper/documents can be seen / downloaded from Official website & submitted through CPP e-portal.
- 12. The competent authority on behalf of the Executive Director, AIIMS Raipur does not bind itself to accept the lowest or any other bid and reserves to itself the authority to reject any or all the bids received without the assignment of any reason. All bids in which any of the prescribed condition is not fulfilled or any condition including that of conditional rebate is put forth by the bidder shall be summarily rejected.
- **13.** Canvassing whether directly or indirectly, in connection with bidders is strictly prohibited and the bids submitted by the contractors who resort to canvassing will be liable to rejection.
- **14.** The Competent Authority, The **Engineer-In-Charge**, reserves to himself the right of accepting the whole or any part of the bid and the bidder shall be bound to perform the same at the rate quoted.
- 15. The contractor shall not be permitted to bid for works in the AIIMS, Raipur responsible for award and execution of contracts, in which his near relative is posted as an officer in any capacity between the grades of Superintending Engineer and Junior Engineer (both inclusive). He shall also intimate the names of persons who are working with him in any capacity or are subsequently employed by him and who are near relatives to any gazette officer in the AIIMS, Raipur. Any breach of this condition by the contractor would render him liable to be removed from the approved list of contractors of this Department.
- **16.** The bid for the works shall remain open for acceptance for a period of **45 days** from the date of opening of bids.

17. Eligibility of Bidders

- (a) The bidder shall be Structural Designer and possess degree of M.E. (Structures) or M.Tech (Structures) from NIT/IIT/Government Engineering College/University recognized by AICTE or UGC.
- (b) The bidder must have experience of minimum 5 years in preparation of architectural and structural drawing and design of Industrial Shed/G+2 Building.
- (c) Goods and services Tax (GST)
 - (i) GST Registration Certificate of the State in which the work is to be taken up, if already obtained by the bidder.
 - (ii) If the bidder has not obtained GST registration in the State in which the work is to be taken up, or as required by GST authorities then in such a case the bidder shall scan and upload following under taking along with other bid documents.

"If work is awarded to me, I/we shall obtain GST registration Certificate of the State, in which work is to be taken up, within one month from the date of receipt of award letter or before release of any payment by AIIMS, whichever is earlier, failing which I/We shall be responsible for any delay in payments which will be due towards me/us on a/c of the work executed and/or for any action taken by AIIMS or GST department in this regard.

18. Signing of bid document:

- **a)** If the bidder is an individual, the bid shall be signed by him above his full type written name and current address.
- **b)** If the bidder is a proprietary firm, the bid shall be signed by the proprietor above his full type written name and the full name of his firm with its current address.
- **c)** If the bidder is a firm in partnership, the bid shall be signed by all the partners of the firm above their full type written names and current addresses, or, alternatively, by a partner holding power of attorney for the firm. In the later case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
- **d)** If the bidder is a limited company or a corporation, the bid shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The bidder should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.

Scope of Work

Preparation of Architectutral and Structural Drawing and Design for various shed including facade in AIIMS Raipur

The Consultancy Services for prepration of Architectural and Structural Drawing and Design is to be provided for the following shed:

- 1) Shed for waiting areas near Dome 2 including Ramp of Dome 1, Dome 2 & Dome 3
- 2) Shed and Ramp for connecting Trauma Building with Medicine Emergency A1 Block at AIIMS Raipur.

The scope of work is as follows:

- 1. Assessment for feasibility of shed in the above mentioned location.
- 2. Preparation and submission of architectural drawings, structural drawing and design including plan, section and elevation, 3D drawings.
- 3. Providing Working Drawings, Facade Detailing, Good For Construction Drawings
- 4. The architectural and structural drawing design prepared shall be vetted by Govt. Engineering College of Chhattisgarh/ NIT/ IIT prior to submission to AIIMS Raipur. The cost of vetting of drawing and design by Govt. Engineering College of Chhattisgarh/ NIT/ IIT shall be borne by the successful bidder at their own expense and nothing in this regard shall be reimbursed to the successful bidder by AIIMS Raipur.
- 5. The roof of the shed shall comprise of Polycarbonate sheet/Tensile roof/GI profile sheet as per the need and demand of AIIMS Raipur.
