Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
