#### REQUIREMENTS FOR ADMISSION OF "SPONSORED" CANDIDATES

- **a.** Candidates who are permanent employees of any Central/State Government/Armed Forces or the Public Sector Undertaking/Autonomous Body can be sponsored by the respective Government/Defence Authorities or the Competent Authorities of PSU/Autonomous Body.
- b. A State Government can sponsor candidates only for those Fellowship Programme which are not available in the State. A certificate regarding non-availability of the Fellowship (for which the candidate is being sponsored) in the concerned State, duly signed by the Secretary/Director General of Health Services of the Central / State Government/ DGAFMS/Competent Authority or PSU/Autonomous Body viz. Director/Executive Head of the concerned organization, should be furnished in the format prescribed for this purpose.
- **c.** All eligible "sponsored" candidates will be called by the Institute for an entrance test.
- **d.** Seats as shown in the prospectus are available for "sponsored" candidates. Sponsored candidates will be designated as "PDCC Fellow".
- **e.** The subject for which the candidate is being sponsored should be clearly specified in the sponsorship form by the sponsoring authority. The candidate can be sponsored for only one subject. The applications of those candidates who are sponsored for more than one subject will not be considered.
- **f.** No "Sponsored" candidate will be paid any emoluments to the Institute during the training period. Such payments will be the responsibility of the sponsoring authority (i.e. Central/State Government or Defence Authorities).
- g. Sponsored candidates must submit/send sponsorship certificate in original from their employers in the following format along with the application form to the Academic Section, Second Floor, Medical College Building, Gate No. 5, AIIMS Raipur, Tatibandh, Raipur. Those who fail to do so should submit it before the date of issue of Admit Cards as mentioned under "AT A GLANCE" in the Prospectus failing which their candidature will be cancelled.

The candidates must have completed the requisite qualification, degree and tenure by 31.05.2023. The candidates who are likely to complete their 3 years requisite qualification, degree and tenure after 31.05.2023 will not be eligible to appear in this examination. Any wrong information provided by candidate on same may invite disciplinary action including debarment from future examination.

#### 3. UPPER AGE LIMIT:

- Upper age limit is 45 years as on 1st July 2023.
- Upper age limit is relaxable for OBC Candidates by a maximum of 3 years.
- Upper age limit is relaxable in case of SC/ST candidates by a maximum of 5 years.
- Upper age limit is relaxable for Ex-Serviceman and Commissioned Officer including ECO, SSCO who have rendered or released on satisfactory assignment with age relaxation by a maximum of 5 years.

• The persons with benchmark disabilities shall be given an upper age relaxation of five years for admission to PDCC for PWD candidates as per Right of persons with Disability Act, 2016.

- 1. For the purpose of application fee, the candidates belonging to SC/ST/OBC (NCL)/EWS/PWBD category, the candidate must possess a certificate issued by competent authority (as applicable to category/format provided by AIIMS Raipur).
- 2. OBC (NCL) certificate must be issued within one year of last date for application 22.05.2023 (i.e. issued between 21.05.2022 to 22.05.2023).
- 3. EWS certificate should be issued on or after on 01.04.2023 to last date of filling of application form i.e. 22.05.2023 based on the income of year 2022-2023.
- 4. ST/SC/PWBD certificate should be issued before the last of the application i.e. 22.05.2023.

A candidate who will be applying for two PDCC courses, he/she will have to appear for both the examinations. Additional time will be provided for the second examination.

#### 7. SCHEME OF MARKING

The question paper will consist of 100 Multiple Choice Questions (MCQs) of 2 hours duration. **There is no negative marking**. Scheme of marking will be as follows:

Correct Answer: One mark (+1)Not answered: Zero mark (0)

#### 8. METHOD OF SELECTION

The percentile scores will be used to determine eligibility for admission. The candidate must secure 50th percentile mark to be eligible for admission. Merit list will be prepared as per percentile score.

#### 9. METHOD OF RESOLVING TIES

If two or more candidates obtain equal percentile score in the entrance examination then their inter-se-merit for admission to the course shall be determined on the basis of the following:-

- A candidate senior in age will rank senior to the candidate junior in age.
- If the age is also the same, then a candidate who has obtained higher marks (Aggregate) in the MBBS examination will rank senior to a candidate who has obtained lesser marks.

#### 10. JOINING

Selected candidate is required to join on or before 15.07.2023. The competent authority may permit an extension of joining till 31.07.2023 based on merit of each case. In case the selected candidate fails to join by this date and no written request for extension is received by 31.07.2023, it will be assumed that he/she does not intend to join the course and the seat will be offered to the next candidate on the waiting list.

Last date for admission to the course will be 31.08.2023. In any circumstances, last date for admission will not be extended after 31.08.2023. This includes candidates on the wait list who may be offered a seat if the selected candidates does not join.

#### 11. COURSE FEE & STIPEND:

- (C) Applicants must fill all the fields **carefully** since after submission of online application request for change in any information at any later stage will <u>not</u> be considered.
- (D) The candidates are requested to fill the correct details regarding name/age/sex/caste/address/educational qualification and other relevant fields mentioned in the application.
- (E) Candidates may please note that unless they make the payment of Application Fee, their application will be treated as INCOMPLETE.
- (F) **Payment of fee:** Candidates can pay the application fee through NEFT. Additional charges viz. bank charges, service tax etc. incurred while making online payment of application fees will be borne by the candidate. **Candidates are advised to take a print of the receipt of fee of Application Form for their records and future reference.** Admit Card will be sent on the email of candidate (as provided in the application form) well in advance of the date of examination.

#### 15. REQUIREMENTS FOR ADMISSION OF OVERSEAS CITIZEN OF INDIA (OCI)

Overseas Citizen of India (OCI) registered under Section 7A of Citizenship Act 1955 are also eligible to appear in PDCC courses and all terms and conditions for Indian Nationals will be applicable to the candidates. The candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test.

#### 16. SUBMISSION OF CASTE CERTIFICATE BY SC/ST/OBC/EWS CANDIDATES
