2. **ESSENTIAL QUALIFICATION:** Having Passed 10+2 with Science - Physics, Chemistry and Biology Subject with minimum 55% marks in the aggregates for General candidates and 50% marks for reserved category candidates.

#### NOTE:-

- 1. Those candidates who have completed 10+2 examination **on or before 31.07.2023**, are eligible to apply but such candidates must furnish proof of passing the qualifying examination with requisite percentage of marks and subjects at the time of counselling failing which their candidature will be cancelled.
- 2. Candidates are required to bring all the original documents with one set of photocopies at the time of counselling.
- 3. OBC-NCL certificate should have been issued between 15.08.2022 to 14.08.2023 (Last Date of Registration).
- 4. EWS certificate should be issued on or after on 01.04.2023 to last date of filling of application form i.e. 14.08.2023 based on the income of year 2022-2023.
- **3. AGE LIMIT** Minimum 17 years and maximum 25 years as on 31.07.2023. However, the relaxation in age will be 05 (five) years for SC, ST candidates and 3 (Three) years for OBC candidates as per Government Rules/Instructions in this regard.

Selection will be made on the basis of aggregate percentage marks of Physics, Chemistry and Biology obtained in 10+2 Examination of CBSE/State Board/any other recognised Board.

If case two or more candidates have secured same aggregate percentage marks, the inter-se-ranking of such candidates shall be determined by the following order of preferences:

- 1. The candidates who have secured higher marks in Biology.
- 2. The candidates who have secured higher marks in Physics.
- 3. The Candidate who is older in age.

The candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test.

#### 13. SUBMISSION OF CASTE CERTIFICATE BY SC/ST/OBC CANDIDATES

- E. Administrator/Secretary to Administrator/Development Officer (Lakshadweep Island) or as authorised in the Constitution.

#### NOTE:

Applicants will be required to produce the necessary certificate in the format provided at the end of the prospectus in support of his/her claim.
