#### **Following shall be the terms and conditions for the proposed stray counseling:**

1. As per the result Final Result Notification No.218/2023 dated 22.11.2023 ([https://docs.aiimsexams.ac.in/sites/Website-AML\\_Result\\_INISS\\_Jan\\_24.pdf](https://docs.aiimsexams.ac.in/sites/Website-AML_Result_INISS_Jan_24.pdf)) issued by AIIMS New Delhi, all eligible candidates can participate in this Stray Counselling for admission in DM/MCh course.
2. The terms and conditions, as mentioned in the DM/MCh prospectus of AIIMS New Delhi for January 2024 session, will be applicable for Stray counselling at AIIMS Raipur.
3. The candidates who are interested in attending Stray counselling on the scheduled date are required to register themselves by clicking on the link <https://forms.gle/7Jmu69vECWrqQUdk8> latest till 05 PM on 26.02.2024.
4. Such candidates who have registered for stray counselling are required to remain physically present at AIIMS Raipur along with all original certificates of qualification on the scheduled date. Candidates without original certificates will not be allowed to attend the Stray Counselling.
5. No authorized representative will be allowed to attend the Stray Counselling.

6. The allocation of seats will be made strictly as per rank/merit of candidates in the entrance examination and on the terms and condition as mentioned in the prospectus.

7. The candidates who have joined DM/MCh course or have opted DM/MCh seat elsewhere are required to bring proof of acceptance of their resignation/seat surrender in original in the Stray Counselling otherwise they will not be allowed to attend the Stray Counselling.

8. The selected candidates are required to complete admission formalities on the same day. No extension under any circumstances will be granted.

9. All the provisionally eligible candidate and who are not holding any seat by allocation are eligible to participate at respective institute in stray Round of Seat Allocation.

10. All candidates who have been allocated a seat in any previous round of seat allocation and have joined/reported on allocated seat as per procedure of joining/reporting & holding the seat are not eligible for the stray round of counselling.

11. All participating candidate must be carrying original documents where accepting a seat will be treated as on the Stray admission and original documents will be deposited on the Stray. Non-joining on any accepted seat will lead to imposition of penalty as applicable to student resigning after admission.

12. Any candidate submits any document which is not valid as per prospectus and any notice published will be treated as providing false information. For example

a) Submitting a document which is not issued between dates as prescribed in the prospectus and submitted by a candidate to obtain eligibility despite knowing the fact that certification is not valid as not issued as prescribed in prospectus.

b) Applying in anticipating of obtaining desired qualification and not obtained on the date as required.

c) False reporting on caste, age, gender, date of acquiring eligibility, date of completion of internship.

d) Any other information which is not true as required in prospectus/ notice and submitted in order to dispute at later stage.

13. If it is established, at any time during the process of Seat allocation of INI-SS January 2024 or later, that applicant has deliberately furnished incorrect information for the purpose of falsification, it shall be treated as an attempt to cheat and the candidature shall be annulled and further legal and disciplinary actions will be taken.
