#### **IMPORTANT NOTES:**

- 1. For the purpose of application fee, the candidates belonging to SC/ST/OBC (NCL)/EWS/PWBD category, the candidate must possess a certificate issued by Competent Authority (as applicable to category/format provided by AIIMS, Raipur).
- 2. OBC (NCL) certificate must have been issued between 23.06.2024 to 22.06.2025.

### 5. METHOD OF SELECTION:

- 1. Written test.
- 2. There are 100 MCQs in the entrance examination.

#### 6. FINAL RESULT:

- A. Final result will be declared based on total marks obtained in Written Examination. The percentile scores will be used to determine eligibility for admission. The candidate must secure 50<sup>th</sup> percentile mark to be eligible for admission. Merit list will be prepared as per percentile score.
- B. Based on the percentile obtained in the entrance examination selected candidate will undergo scrutiny for the verification of their documents and final selected list of the candidates will be prepared accordingly subject to fulfilling the eligibility in all terms described in the eligibility criteria mentioned the **clause 2** of the advertisement.

After the entrance examination provisional selection and waiting list will be published as soon as possible in this official website of AIIMS Raipur i.e. <a href="www.aiimsraipur.edu.in">www.aiimsraipur.edu.in</a>.

#### 7. METHOD OF RESOLVING TIES:

If two or more candidates obtain equal percentile score in the entrance examination then their inter-semerit for admission to the course shall be determined on the basis of the following:-

- i. A candidate who is from Medical/Nursing stream will be rank higher.
- ii. If stream is same then a candidate who has obtained higher marks (Aggregate) in the Essential Qualification will rank higher to a candidate who has obtained lesser marks
- iii. If the stream and marks are also the same, a candidate older in age will rank higher to the candidate younger in age.

Selected candidates are required to join within a month after the declaration of the result. The process of document verification and joining will be conducted by the Academic Section, AIIMS Raipur.

# 13. REQUIREMENTS FOR ADMISSION OF OVERSEAS CITIZEN OF INDIA (OCI):

Overseas Citizen of India (OCI) registered under Section 7A of Citizenship Act 1955 are also eligible to appear in PG courses and all terms and conditions for Indian Nationals will be applicable to the candidates. The candidate will submit proof of Registration as OCI under Section 7A of Citizenship Act 1955 to be eligible to appear for this test.

#### 14. SUBMISSION OF CASTE CERTIFICATE BY SC/ST/OBC CANDIDATES:
