And if financial	The bids shall be evaluated under the Quality and Cost Based Selection (QCBS) method with 30% weightage to Technical Evaluation and 70% weightage to Financial Evaluation. The bidder securing highest combined weighted score, as computed and ranked by the GeM portal, shall be declared as the Highest Evaluated Bidder (H1) and considered for award of contract, subject to fulfillment of all tender conditions. A bid shall be considered substantially responsive if it conforms to all terms and conditions of the bid document without any material deviation.
