NOTICE REGARDING REVISED ELIGIBILITY STATUS OF 'PARTIALLY ELIGIBLE' AND 'NOT-ELIGIBLE' CANDIDATES AFTER RESOLUTION OF THEIR CLAIM/OBJECTION WITH RESPECT TO ROUND-1 OF SEAT ALLOCATION OF NORCET-2021 FOR RECRUITMENT TO THE POST OF NURSING OFFICER AT AIIMS RAIPUR

1. This is with reference to AIIMS Raipur notice dated 25.03.2022 regarding provisional eligibility list of the candidates on the basis of online document verification, who have been allocated and have accepted AIIMS Raipur in the round 1 of seat allocation of NORCET-2021.

Candidates must note that their candidature is purely provisional and is subject to being declared '**Eligible**' during verification of their original documents at the time of joining at AIIMS Raipur. Further, if at any stage it is found that the selected candidate does not fulfill any of the eligibility criteria or if he/she has concealed or given incorrect information which if known earlier, would have rendered him/her ineligible for selection, his/her selection/appointment to the post will be cancelled forthwith at any stage without assigning any reason.
