This is to certify that *CINTec Plus Cytology Kit* is a proprietary product of Roche Diagnostics having an exclusive patent for the detection of antigens, a primary monoclonal mouse antibody clone E6H4TM directed to human p16 INK4a protein and a primary monoclonal rabbit antibody 274-11 AC3 directed against human KI-67 protein are used.

It is a ready-to-use visualization reagents comprising:

- il. A polymer reagent conjugated to horseradish peroxidase and goat anti-mouse Fab'antibody fragments.
- ii. A polymer reagent conjugated to alkaline phosphatase and anti-mouse Fab' antibody fragments are used.
