Terms & Conditions:

- 1) Schedule of Quantity attached in CPP Portal.
- 2) **Time allowed for the completion of the work is 10 Days.** It will be reckoned after the day award of the work.
- 3) Statuary clearance like pollution control & Electrical Board etc. formalities are in scope of agency/vendor.
- 4) Loading and Unloading including transporting charges are in scope of agency/vendor
- 5) The bidder shall be responsible for arranging and maintaining at his own cost all materials, tools & plants, water, electricity access, facilities for workers and all other services required for executing the work.
- 6) **No mobilization advance** will be allowed.
- 7) **The work order may be terminated at any time by the department as per requirement.**

8) The work will be done in a running hospital, hence the work to be done as per the rules and instructions of Engineer-In-Charge. All the conditions of work at site are applicable to the successful bidder.

9) Authorization Certificate from the Source Manufacturer/OEM

10) Make: Grundfos/Kirloskar/Wilo/Crompton

11) Use of quotations up to Rs Five lakh in each instance shall be adopted for procurement of readily available goods that are not specially produced to the particular specifications and for which there is an established market;

12) Procurement entity shall not divide its procurement into separate contracts to bring the amount less than the amount set forth for such purpose;

13) Procurement entity shall request quotations from as many contractors as practicable but positively from at least three contractors. Each contractor from whom a quotation is requested, shall be informed whether any elements and other than the charges for the goods themselves, such as, transportation and insurance charges, duties and taxes are to be included in the price;

14) Each contractor or contractor is permitted to give only one price quotation and is not permitted to change its quotation;

15) Award of work through quotations shall be resorted only in emergent cases and suitable reasons shall be recorded.

INFORMATION TO THE BIDDERS:-

1. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website of AIIMS Raipur.
2. Work has to be done as per CPWD (E/M) specification and CPWD Works Manual 2014 and as per direction of Engineer- In-charge.
3. **Signing of bid document :**
 - a. If the bidder is an individual, the bid shall be signed by him above his full type written name and current address.
 - b. If the bidder is a proprietary firm, the bid shall be signed by the proprietor above his full type written name and the full name of his firm with its current address.
 - c. If the bidder is a firm in partnership, the bid shall be signed by all the partners of the firm above their full type written names and current addresses, or, alternatively, by a partner holding power of attorney for the firm. In the later case a certified copy of the power of attorney should accompany the application. In both cases a certified copy of the partnership deed and current address of all the partners of the firm should accompany the application.
 - d. If the bidder is a limited company or a corporation, the bid shall be signed by a duly authorized person holding power of attorney for signing the application accompanied by a copy of the power of attorney. The bidder should also furnish a copy of the Memorandum of Articles of Association duly attested by a Public Notary.
