

- <u>1.</u> <u>"Teleflex Medical"</u> owns all the rights title and interest in the patents, trademarks, trade names, inventions, copyrights, know how, trade secrets and any other intellectual property of WECK HEM-O-LOK, the original Hem-o-lok invented and designed by Edward Weck, which falls under the Ligation Clip category for use in procedures involving ligation of vessels or tissue structures. Surgeon should apply appropriate size clip for the size of vessel or tissue structures to be ligated so that the clip completely encompasses the vessel or tissue structures. Weck Hem-o-lok ligating clips are available in a range of sizes starting from medium to extra-large for ligating vessel sizes from 2mm to 16mm. Hem-o-lok clip appliers are available in open surgery format as well as endoscopic surgery format with different sizes and angles based on surgeon's preference.
- 2. The following are the details of the /product:
 - Hem-o-lok ligating clips are made of acetal homopolymer that is inert, non-conductive, radiolucent and does not interfere with CT, MIR or X-ray diagnostics.
 - Hem-o-lok ligating clips have bosses designed to retain the clip in the applier jaws.
 - Hem-o-lok ligating clips are bow-shaped allowing it to be removed with a Hem-o-lok clip remover, if needed.
 - Hem-o-lok ligating clips have an integrated teeth interface with the vessel and are designed to
 prevent slippage.
 - Hem-o-lok ligating clips have a locking mechanism that provides tactile feedback and secure closure.
 - Hem-o-lok clip appliers are reusable devices compatible with Weck Hem-o-lok ligating clips.
 - Hem-o-lok clip appliers are made from German steel with a matte finish to avoid any visual disturbance during surgery.
